12	Sec. 204. The civil service commission shall bill the

7	conservation and recreation legacy fund, \$6,000,000.00 for the
8	fiscal year ending September 30, 2014.
9	Sec. 208. From the funds appropriated in part 1 for
10	information technology, departments and agencies shall pay user
11	fees to the department of technology, management, and budget for
12	technology-related services and projects. The user fees shall be
13	subject to provisions of an interagency agreement between the
14	department and agencies and the department of technology,
15	management, and budget.
16	Sec. 210. Funds appropriated in part 1 shall not be used for
17	the purchase of foreign goods or services, or both, if
18	competitively priced and of comparable quality American goods or
19	services, or both, are available. Preference shall be given to
20	goods or services, or both, manufactured or provided by Michigan
21	businesses if they are competitively priced and of comparable
22	quality. In addition, preference should be given to goods or
23	services, or both, that are manufactured or provided by Michigan
24	businesses owned and operated by veterans, if they are
25	competitively priced and of comparable quality.
26	Sec. 211. The director of the department shall take all
27	reasonable steps to ensure businesses in deprived and depressed

- 1 communities compete for and perform contracts to provide services
- 2 or supplies, or both. The director shall strongly encourage firms
- 3 with which the department contracts to subcontract with certified
- 4 businesses in depressed and deprived communities for services,
- 5 supplies, or both.
- 6 Sec. 212. The department shall not take disciplinary action
- 7 against an employee for communicating with a member of the
- 8 legislature or his or her staff.
- 9 Sec. 214. Funds appropriated in part 1 shall not be used by a
- 10 principal executive department, state agency, or authority to hire
- 11 a person to provide legal services that are the responsibility of
- 12 the attorney general. This prohibition does not apply to legal
- 13 services for bonding activities and for those outside services that
- 14 the attorney general authorizes.
- 15 Sec. 215. (1) In addition to the funds appropriated in part 1,
- 16 there is appropriated an amount not to exceed \$3,000,000.00 for
