3       Sec. 207. Pursuant to section 43703(3) of the natural  
4 resources and environmental protection act, 1994 PA 451, MCL  
5 324.43703, there is appropriated from the game and fish protection  
6 trust fund to the game and fish protection account of the Michigan  
7 conservation and recreation legacy fund, \$6,000,000.00 for the  
8 fiscal year ending September 30, 2015.

9       Sec. 210. Funds appropriated in part 1 shall not be used for  
10 the purchase of foreign goods or services, or both, if  
11 competitively priced and of comparable quality American goods or  
12 services, or both, are available. Preference shall be given to  
13 goods or services, or both, manufactured or provided by Michigan  
14 businesses if they are competitively priced and of comparable  
15 quality. In addition, preference should be given to goods or  
16 services, or both, that are manufactured or provided by Michigan  
17 businesses owned and operated by veterans, if they are  
18 competitively priced and of comparable quality.

19       Sec. 211. The director of the department shall take all

7 outside services that the attorney general authorizes.

8       Sec. 215. (1) In addition to the funds appropriated in part 1,  
9 there is appropriated an amount not to exceed \$3,000,000.00 for  
10 federal contingency funds. These funds are not available for  
11 expenditure until they have been transferred to another line item  
12 in part 1 under section 393(2) of the management and budget act,  
13 1984 PA 431, MCL 18.1393.

14       (2) In addition to the funds appropriated in part 1, there is  
15 appropriated an amount not to exceed \$10,000,000.00 for state  
16 restricted contingency funds. These funds are not available for  
17 expenditure until they have been transferred to another line item  
18 in part 1 under section 393(2) of the management and budget act,  
19 1984 PA 431, MCL 18.1393.

20       (3) In addition to the funds appropriated in part 1, there is  
21 appropriated an amount not to exceed \$100,000.00 for local  
22 contingency funds. These funds are not available for expenditure  
23 until they have been transferred to another line item in part 1  
24 under section 393(2) of the management and budget act, 1984 PA 431,  
25 MCL 18.1393.

26       (4) In addition to the funds appropriated in part 1, there is  
27 appropriated an amount not to exceed \$1,000,000.00 for private

1 contingency funds. These funds are not available for expenditure  
2 until they have been transferred to another line item in part 1  
3 under section 393(2) of the management and budget act, 1984 PA 431,  
4 MCL 18.1393.

5       Sec. 217. The department and agencies receiving appropriations  
6 in part 1 shall receive and retain copies of all reports funded  
7 from appropriations in part 1. Federal and state guidelines for  
8 short-term and long-term retention of records shall be followed.  
9 The department may electronically retain copies of reports unless  
10 otherwise required by federal and state guidelines.

11       Sec. 218. The departments and agencies receiving  
12 appropriations in part 1 shall prepare a report on out-of-state  
13 travel expenses not later than January 1 of each year. The travel  
14 report shall be a listing of all travel by classified and  
15 unclassified employees outside this state in the immediately  
16 preceding fiscal year that was funded in whole or in part with  
17 funds appropriated in the department's budget. The report shall be  
18 submitted to the senate and house appropriations committees, the  
19 house and senate fiscal agencies, and the state budget director.  
20 The report shall include the following information:

25 of technology, management, and budget to maintain a searchable  
26 website accessible by the public at no cost that includes, but is  
27 not limited to, all of the following:

1 (a) Fiscal year-to-date expenditures by category.

2 (b) Fiscal year-to-date expenditures by appropriation unit.

3 (c) Fiscal year-to-date payments to a selected vendor,  
4 including the vendor name, payment date, payment amount, and  
5 payment description.

6 (d) The number of active department employees by job  
7 classification.

8 (e) Job specifications and wage rates.

9 Sec. 235. The department shall maintain, on a publicly  
10 accessible website, a department scorecard that identifies, tracks,  
11 and regularly updates key metrics that are used to monitor and  
12 improve the agency's performance.

13 Sec. 237. Total authorized appropriations from all sources  
14 under part 1 for legacy costs for the fiscal year ending September  
15 30, 2015 are \$46,680,700.00. From this amount, total agency  
16 appropriations for pension-related legacy costs are estimated at  
17 \$26,090,800.00. Total agency appropriations for retiree health care  
18 legacy costs are estimated at \$20,589,900.00.

19 **DEPARTMENT INITIATIVES**

20 Sec. 250. As a condition on the expenditure of funds in part 1  
21 for the Michigan conservation corps, the department shall work with  
22 the Michigan civilian conservation corps partnership steering  
23 committee established in section 22 of the Michigan civilian  
24 conservation corps act, 1984 PA 22, MCL 409.322, to plan for a  
25 nonprofit Michigan civilian conservation corps that is administered  
26 outside of state government.



1       Sec. 251. From the amounts appropriated in part 1 for invasive  
2 species prevention and control, the department shall allocate not  
3 less than \$3,770,000.00 for grants for the prevention, detection,  
4 eradication, and control of invasive species.

5       DEPARTMENT SUPPORT SERVICES

6       Sec. 302. The department may charge land acquisition projects  
7 appropriated for the fiscal year ending September 30, 2015, and for  
8 prior fiscal years, a standard percentage fee to recover actual  
9 costs, and may use the revenue derived to support the land  
10 acquisition service charges provided for in part 1.

11       Sec. 303. As appropriated in part 1, the department may charge  
12 both application fees and transaction fees related to the exchange  
13 or sale of state-owned land or rights in land authorized by part 21  
14 of the natural resources and environmental protection act, 1994 PA  
15 451, MCL 324.2101 to 324.2162. The fees shall be set by the  
16 director of the department at a rate which allows the department to  
17 recover its costs for providing these services.

18       COMMUNICATION AND CUSTOMER SERVICES

19       Sec. 404. For the purposes of administering the museum store  
20 as provided in section 7a of 1913 PA 271, MCL 399.7a, the  
21 department is exempt from section 261 of the management and budget  
22 act, 1984 PA 431, MCL 18.1261.

23       Sec. 405. As appropriated in part 1, proceeds in excess of  
24 costs incurred in the conduct of auctions, sales, or transfers of  
25 artifacts no longer considered suitable for the collections of the

1 state historical museum may be expended upon receipt for additional  
2 material for the collection. The department shall notify the  
3 chairpersons, vice chairpersons, and minority vice chairpersons of  
4 the senate and house appropriations subcommittees on natural  
5 resources 1 week prior to any auctions or sales. Any unexpended  
6 funds may be carried forward into the next succeeding fiscal year.

7 Sec. 406. As appropriated in part 1, funds collected by the  
8 department for historical markers; document reproduction and  
9 services; conferences, admissions, workshops, and training classes;  
10 and the use of specialized equipment, facilities, exhibits,  
11 collections, and software shall be used for expenses necessary to  
12 provide the required services. The department may charge fees for  
13 the aforementioned services, including admission fees. Any  
14 unexpended funds may be carried forward into the next succeeding  
15 fiscal year.

16 Sec. 408. By October 21, 2014, the department shall submit to  
17 the senate and house appropriations subcommittees on natural  
18 resources a report on all land transactions approved by the  
19 commission in the fiscal year ending September 30, 2014. For each  
20 land transaction, the report shall include the size of the parcel,  
21 the county and municipality in which the parcel is located, the  
22 dollar amount of the transaction, the fund source affected by the  
23 transaction, and whether the transaction is by purchase, public  
24 auction, transfer, exchange, or conveyance.

25 **WILDLIFE DIVISION**

26 Sec. 503. From the funds appropriated in part 1, the

1 department shall produce a report detailing any efforts undertaken  
2 to enforce the invasive species order on swine raised under the  
3 husbandry of residents of this state. The report shall include fund  
4 sources used and the amount of expenditures and shall be submitted  
5 to the legislature by December 31, 2014.

6 Sec. 504. From the funds appropriated in part 1, the  
7 department shall provide a report to the legislature on the use of  
8 registration fees collected from privately owned cervid operations.  
9 Appropriations in part 1 from cervidae licensing and inspection  
10 fees shall not be used for anything other than work directly  
11 related to the regulation of privately owned cervid operations in  
12 this state.

### 13 **FISHERIES DIVISION**

14 Sec. 601. (1) From the appropriation in part 1 for aquatic  
15 resource mitigation, not more than \$758,000.00 shall be allocated  
16 for grants to watershed councils, resource development councils,  
17 soil conservation districts, local governmental units, and other  
18 nonprofit organizations for stream habitat stabilization and soil  
19 erosion control.

20 (2) The fisheries division in the department shall develop  
21 priority and cost estimates for all projects recommended for grants  
22 under subsection (1).

23 Sec. 602. As a condition of expenditure of fisheries  
24 management appropriations under part 1, the department of natural  
25 resources shall not impede the certification process for water  
26 control structures on Michigan waterways. The department of natural

resources shall fund from funds appropriated in part 1 all non-water-quality studies or requirements that the department requests of either of the following:

(a) The department of environmental quality as a condition for issuance of a certification under section 401 of the federal water pollution control act, 33 USC 1341.

(b) The federal energy regulatory commission as a condition of licensing under the federal power act, 16 USC 791a to 825r.

Sec. 603. The department shall provide a quarterly report to the legislature on use of funding provided for cormorant management. The department shall use general fund/general purpose revenue for this purpose and submit revenue appropriated in part 1 for cormorant management to the United States department of agriculture animal and plant health inspection service to allow for increased taking of cormorants and their nests. If any funds appropriated for cormorant management are retained by the department, or other funds become available for this purpose, the department shall use those funds to harass cormorants with the goal of reducing foraging attempts on fish populations.

#### **PARKS AND RECREATION DIVISION**

Sec. 702. The department shall notify the house and senate appropriations subcommittees on natural resources and the house and senate fiscal agencies if it intends to reduce operations or reduce recreation opportunities in any state park or recreation area.

Sec. 704. If senate bills 873 through 877 of the 97th Legislature are enacted into law, from the appropriations in part

1 1, the department shall allocate \$200,000.00 for the Pure Michigan  
2 trails program as described in those bills.

3 Sec. 705. From the amounts appropriated in part 1, the  
4 department shall allocate \$100,000.00 for the completion of the  
5 Burt Lake connector trail.

6 **FOREST RESOURCES DIVISION**

7 Sec. 802. Of the funds appropriated in part 1, the department  
8 shall, subject to the forest certification process, prescribe  
9 treatment on 79,000 acres, prepare appropriate treatment for not  
10 less than 67,500 acres at the current average rate of 12.5 to 15  
11 cords per acre, and offer those cords for sale in the 2014-2015  
12 fiscal year, provided that the department shall take into  
13 consideration the impact of timber harvesting on wildlife habitat  
14 and recreation uses. The department shall, subject to the forest  
15 certification process, increase marking or treatment of hardwood  
16 timber for sale and harvest by 10% over 2013-2014 fiscal year  
17 levels. In addition, the department shall take into consideration  
18 silvicultural analysis and report annually to the legislature on  
19 plans and efforts to address factors limiting management of timber.  
20 The department shall increase the number of prepared acres if it  
21 appears that regional market demand requires increased volumes of  
22 harvested timber. The department shall provide quarterly reports on  
23 the number of acres treated, pursuant to this section, to the  
24 senate and house appropriations subcommittees on natural resources  
25 and the standing committees of the senate and house of  
26 representatives with primary responsibility for natural resources

1 issues. The department shall complete and deliver these reports no  
2 later than 45 days after the end of the fiscal quarter.

3 Sec. 803. In addition to the money appropriated in part 1, the  
4 department may receive and expend money from federal sources for  
5 the purpose of providing response to wildfires as required by a  
6 compact with the federal government. If additional expenditure  
7 authorization is required, the department shall notify the state  
8 budget office that expenditure under this section is required. The  
9 department shall notify the house and senate appropriations  
10 subcommittees on natural resources and the house and senate fiscal  
11 agencies of the expenditures under this section by November 1,  
12 2015.

13 Sec. 804. The department shall continue to work cooperatively  
14 with horseback riding interests to maximize riding opportunities in  
15 the state.

16 Sec. 805. The department shall spend amounts appropriated in  
17 part 1 for forest-related activities to employ or contract for  
18 sufficient foresters to mark timber, pursuant to section 802.

19 Sec. 807. (1) In addition to the funds appropriated in part 1,  
20 there is appropriated from the disaster and emergency contingency  
21 fund up to \$800,000.00 to cover costs related to any disaster as  
22 defined in section 2 of the emergency management act, 1976 PA 390,  
23 MCL 30.402.

24 (2) Funds appropriated under subsection (1) shall not be  
25 expended unless the state budget director recommends the  
26 expenditure and the department notifies the house and senate  
27 committees on appropriations. By December 1 each year, the

1 department shall provide a report to the senate and house fiscal  
2 agencies and the state budget office on the use of the disaster and  
3 emergency contingency fund during the prior fiscal year.

4 (3) If federal emergency management agency (FEMA)  
5 reimbursement is approved for costs paid from the disaster and  
6 emergency contingency fund, the federal revenue shall be deposited  
7 into the disaster and emergency contingency fund.

8 (4) Unexpended and unencumbered funds remaining in the  
9 disaster and emergency contingency fund at the close of the fiscal  
10 year shall not lapse to the general fund and shall be carried  
11 forward and be available for expenditures in subsequent fiscal  
12 years.

13 Sec. 808. Using the funds appropriated in part 1, by April 1,  
14 2015, the department shall develop a lawful and reasonable plan  
15 designed to motivate lessees under state-granted oil and gas leases  
16 past their primary term to undertake warranted new operations to  
17 ensure that department-managed minerals are fully developed in an  
18 orderly manner to increase and optimize production. The plan shall  
19 be consistent with department procedure number 2306.E8.

## 20 **LAW ENFORCEMENT**

21 Sec. 901. The appropriation in part 1 for snowmobile law  
22 enforcement grants shall be used by the department to provide  
23 grants to county law enforcement agencies to enforce part 821 of  
24 the natural resources and environmental protection act, 1994 PA  
25 451, MCL 324.82101 to 324.82160, including rules promulgated under  
26 that part and ordinances enacted pursuant to that part. The

1 department shall consider the number of enforcement hours and the  
2 number of miles of snowmobile trails in each county in allocating  
3 these grants. Any funds not distributed to counties revert back to  
4 the snowmobile registration fee subaccount created under section  
5 82111 of the natural resources and environmental protection act,  
6 1994 PA 451, MCL 324.82111. Counties shall provide semiannual  
7 reports to the department on the use of grant money received under  
8 this section.

9       Sec. 902. The department shall provide a report on the marine  
10 safety grant program to the senate and house appropriations  
11 subcommittees on natural resources and the senate and house fiscal  
12 agencies by December 1, 2014. The report shall include the  
13 following information for the preceding year: the total amount of  
14 revenue received for watercraft registrations, the amount deposited  
15 into the marine safety fund, and the expenditures made from the  
16 marine safety fund, including the amounts expended for department  
17 administration, other state agencies, the law enforcement division,  
18 and grants to counties. The report shall also include the  
19 distribution methodology used by the department to distribute the  
20 marine safety grants and a list of the grants and the amounts  
21 awarded by county.

## 22 **GRANTS**

23       Sec. 1001. Federal pass-through funds to local institutions  
24 and governments that are received in amounts in addition to those  
25 included in part 1 for grants to communities - federal oil, gas,  
26 and timber payments and that do not require additional state



1 matching funds are appropriated for the purposes intended. By  
2 November 30, 2014, the department shall report to the senate and  
3 house appropriations subcommittees on natural resources, the senate  
4 and house fiscal agencies, and the state budget director on all  
5 amounts appropriated under this section during the fiscal year  
6 ending September 30, 2014.

7       Sec. 1002. Subject to part 811 of the natural resources and  
8 environmental protection act, 1994 PA 451, MCL 324.81101 to  
9 324.81150, from the funds appropriated in part 1 for off-road  
10 vehicle trail improvements grants, not less than \$980,000.00 shall  
11 be spent on the development of new trails in accordance with the  
12 off-road vehicle trail expansion plan submitted to the legislature  
13 pursuant to section 807 of article 14 of 2005 PA 154.

#### 14 **CAPITAL OUTLAY**

15       Sec. 1103. The appropriations in part 1 for capital outlay  
16 shall be carried forward at the end of the fiscal year consistent  
17 with the provisions of section 248 of the management and budget  
18 act, 1984 PA 431, MCL 18.1248.

#### 19 **ONE-TIME BASIS ONLY APPROPRIATIONS**

20       Sec. 1201. Using funds appropriated in part 1, the department  
21 shall conduct a study to determine the feasibility of deepening the  
22 Saginaw River from the 6th Street turning basin to the Saginaw Bay  
23 for the purpose of increasing economic activity in the region.

## GENERAL SECTIONS
