SUBSTITUTE FOR

SENATE BILL NO. 783

A bill to amend 2008 IL 1, entitled "Michigan medical marihuana act," by amending section 7 (MCL 333.26427).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 7. Scope of Act.
- 2 Sec. 7. (a) The medical use of marihuana is allowed under
- 3 state law to the extent that it is carried out in accordance with
- 4 the provisions of this act.
- 5 (b) This act shall DOES not permit any person to do any of the
- 6 following:
- 7 (1) Undertake any task under the influence of marihuana, when
- 8 doing so would constitute negligence or professional malpractice.
- 9 (2) Possess marihuana, or otherwise engage in the medical use

- 1 of marihuana AT ANY OF THE FOLLOWING LOCATIONS:
- 2 (A) in IN a school bus. +
- 3 (B) on ON the grounds of any preschool or primary or secondary
- 4 school. ; or
- 5 (C) in IN any correctional facility.
- 6 (3) Smoke marihuana AT ANY OF THE FOLLOWING LOCATIONS:
- 7 (A) on ON any form of public transportation. ; or
- 8 (B) in IN any public place, WHICH INCLUDES ANY PORTION OF
- 9 PRIVATE PROPERTY THAT IS OPEN TO THE PUBLIC.
- 10 (C) ON PRIVATE PROPERTY, IN VIOLATION OF A PROHIBITION
- 11 ESTABLISHED BY THE PROPERTY OWNER.
- 12 (4) Operate, navigate, or be in actual physical control of any
- 13 motor vehicle, aircraft, or motorboat while under the influence of
- 14 marihuana.
- 15 (5) Use marihuana if that person does not have a serious or
- 16 debilitating medical condition.
- 17 (c) Nothing in this act shall be construed to require ANY OF
- 18 THE FOLLOWING:
- 19 (1) A government medical assistance program or commercial or
- 20 non-profit health insurer to reimburse a person for costs
- 21 associated with the medical use of marihuana.
- 22 (2) An employer to accommodate the ingestion of marihuana in
- 23 any workplace or any employee working while under the influence of
- 24 marihuana.
- 25 (3) A PRIVATE PROPERTY OWNER TO LEASE RESIDENTIAL PROPERTY TO
- 26 ANY PERSON WHO SMOKES OR CULTIVATES MARIHUANA ON THE PREMISES, IF
- 27 THE PROHIBITION AGAINST SMOKING OR CULTIVATING MARIHUANA IS IN THE

1 WRITTEN LEASE.

- 2 (d) Fraudulent representation to a law enforcement official of
- 3 any fact or circumstance relating to the medical use of marihuana
- 4 to avoid arrest or prosecution shall be IS punishable by a fine of
- 5 \$500.00, which shall be IS in addition to any other penalties that
- 6 may apply for making a false statement or for the use of marihuana
- 7 other than use undertaken pursuant to this act.
- 8 (e) All other acts and parts of acts inconsistent with this
- 9 act do not apply to the medical use of marihuana as provided for by
- 10 this act.
