A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 201 and 201a (MCL 388.1801 and 388.1801a),
section 201 as amended by 2015 PA 5 and section 201a as amended by
2014 PA 196.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 201. (1) Subject to the conditions set forth in this

7 Sec. 201a. It is the intent of the legislature to provide
8 appropriations for the fiscal year ending on September 30, ~~2016~~
9 **2017** for the items listed in section 201. The fiscal year ~~2015-2016~~
10 **2016-2017** appropriations are anticipated to be the same as those
11 for fiscal year ~~2014-2015, 2015-2016~~, except that the amounts will
12 be adjusted for changes in retirement costs, caseload and related
13 costs, federal fund match rates, economic factors, and available
14 revenue. These adjustments will be determined after the January
15 ~~2015-2016~~ consensus revenue estimating conference.
