- 18 (b) Fiscal year-to-date expenditures by appropriation unit.
- (c) Fiscal year-to-date payments to a selected vendor,
- 20 including the vendor name, payment date, payment amount, and
- 21 payment description.
- 22 (d) The number of active department employees by job
- 23 classification.
- (e) Job specifications and wage rates.
- 25 Sec. 208. The departments and agencies receiving
- 26 appropriations in part 1 shall use the Internet to fulfill the
- 27 reporting requirements of this part. This requirement may include

- 1 transmission of reports via electronic mail to the recipients
- 2 identified for each reporting requirement, or it may include
- 3 placement of reports on an Internet or Intranet site.
- 4 Sec. 209. Funds appropriated in this part and part 1 shall not
- 5 be used for the purchase of foreign goods or services, or both, if
- 6 competitively priced and of comparable quality American goods or
- 7 services, or both, are available. Preference shall be given to
- 8 goods or services, or both, manufactured or provided by Michigan
- 9 businesses, if they are competitively priced and of comparable
- 10 quality. In addition, preference shall be given to goods or
- 11 services, or both, that are manufactured or provided by Michigan
- 12 businesses owned and operated by veterans, if they are
- 13 competitively priced and of comparable quality.
- 14 Sec. 210. The department shall take all reasonable steps to
- 15 ensure businesses in deprived and depressed communities compete for
- 16 and perform contracts to provide services or supplies, or both. The
- 17 director of the department shall strongly encourage firms with
- 18 which the department contracts to subcontract with certified
- 19 businesses in depressed and deprived communities for services,
- 20 supplies, or both.
- Sec. 215. The department shall not take disciplinary action
- against an employee for communicating with a member of the
- 23 legislature or his or her staff.
- Sec. 216. (1) Notwithstanding any other provision of this
- 25 part, the schedule of programs in part 1 lists programs which may,
- 26 but are not required to be, funded under part 1.
- 27 (2) Notwithstanding any other provisions of this part, the

- 3 Sec. 218. The departments and agencies receiving
- 4 appropriations in this part and part 1 shall prepare a report on

- 8 preceding fiscal year that was funded in whole or in part with
- 9 funds appropriated in the department's budget. The report shall be
- 10 submitted to the senate and house appropriations committees, the
- 11 house and senate fiscal agencies, and the state budget director.

- 13 (a) The dates of each travel occurrence.

- 18 and the proportion funded with other revenues.
- 19 Sec. 219. The department shall provide quarterly reports to
- 20 the subcommittees, the senate and house fiscal agencies, and the
- 21 state budget office, which shall provide the following data:
- 22 (a) A list of all major work projects, including a status
- 23 report of each project.
- 24 (b) The department's financial status, featuring a report of
- 25 budgeted versus actual expenditures by part 1 line item including a
- 26 year-end projection of budget requirements. If projected department
- 27 budget requirements exceed the allocated budget, the report shall

- 1 include a plan to reduce overall expenses while still satisfying
- 2 specified service level requirements.
- 3 (c) A report on the status of performance metrics cited in
- 4 this part and information required to be reported in this part.
- 5 (d) The number of active employees at the close of the fiscal
- 6 quarter by job classification and program.
- 7 (e) A summary of fund shifts, that have been approved by the
- 8 state budget office, that have occurred between items listed in the
- 9 schedule of programs mentioned in part 1.
- 10 Sec. 222. The appropriations in part 1 are for the core
- 11 services, support services, and work projects of the department,
- 12 including, but not limited to, the following core services:
- (a) Armories and joint force readiness.
- 14 (b) National Guard training facilities and air bases.
- (c) Michigan youth challeNGe academy.
- 16 (d) Military family relief fund.
- 17 (e) Starbase grant.
- 18 (f) National Guard tuition assistance program.
- 19 (g) Michigan veterans affairs agency administration.
- 20 (h) Veterans service grants.
- 21 (i) Veterans' trust fund administration.
- (j) Veterans' trust fund grants.
- (k) Grand Rapids veterans' home.
- (l) Board of managers (Grand Rapids).
- 25 (m) D.J. Jacobetti veterans' home.
- (n) Board of managers (Jacobetti).
- Sec. 225. Funds appropriated in this part and part 1 shall not

- 1 be used by the department to hire a person to provide legal
- 2 services that are the responsibility of the attorney general. This
- 3 prohibition does not apply to legal services for bonding activities
- 4 and for those activities that the attorney general authorizes.
- 5 Sec. 228. Not later than November 30, the state budget office
- 6 shall prepare and transmit a report that provides for estimates of
- 7 the total general fund/general purpose appropriations lapses at the
- 8 close of the prior fiscal year. This report shall summarize the
- 9 projected year-end general fund/general purpose appropriations
- 10 lapses by major departmental program or program areas. The report
- 11 shall be transmitted to the office of the state budget, the
- 12 chairpersons of the senate and house standing committees on
- 13 appropriations, the subcommittees, and the senate and house fiscal
- 14 agencies.
- 15 Sec. 229. Within 14 days after the release of the executive
- 16 budget recommendation, the department shall cooperate with the
- 17 state budget office to provide the senate and house appropriations
- 18 chairs, the subcommittees, and the senate and house fiscal agencies
- 19 with an annual report on estimated state restricted fund balances,
- 20 state restricted fund projected revenues, and state restricted fund
- 21 expenditures for the fiscal years ending September 30, 2015 and
- 22 September 30, 2016.
- 23 Sec. 230. The department shall maintain, on a publicly
- 24 accessible website, a department scorecard that identifies, tracks,
- 25 and regularly updates key metrics that are used to monitor and
- 26 improve the agency's performance.
- 27 Sec. 231. Total authorized appropriations from all sources

- 1 under part 1 for legacy costs for the fiscal year ending September
- 2 30, 2016 are \$19,866,900.00. From this amount, total agency
- 3 appropriations for pension-related legacy costs are estimated at
- 4 \$11,276,300.00, and total agency appropriations for retiree health
- 5 care legacy costs are estimated at \$8,590,600.00.
- 6 Sec. 232. The appropriations in part 1 for capital outlay
- 7 shall be carried forward at the end of the fiscal year consistent
- 8 with section 248 of the management and budget act, 1984 PA 431, MCL
- **9** 18.1248.
- 10 Sec. 233. Sixty days prior to the public announcement of the
- 11 intention to sell any department real property, the department
- 12 shall submit notification of that intent to the subcommittees and
- 13 the senate and house fiscal agencies.
- Sec. 234. The 1-time appropriations in part 1 for special
- 15 maintenance shall be carried forward at the end of the fiscal year
- 16 consistent with section 248 of the management and budget act, 1984
- **17** PA 431, MCL 18.1248.
- 18 Sec. 240. In addition to the metrics required under section
- 19 447 of the management and budget act, 1984 PA 431, MCL 18.1447, for
- 20 each new program or program enhancement for which funds in excess
- 21 of \$500,000.00 are appropriated in part 1, the department shall
- 22 provide not later than November 1, 2015 a list of program-specific
- 23 metrics intended to measure its performance based on a return on
- 24 taxpayer investment. The department shall deliver the program-
- 25 specific metrics to members of the senate and house subcommittees
- 26 that have subject matter jurisdiction for this budget, fiscal
- 27 agencies, and the state budget director. The department shall

- 1 provide an update on its progress in tracking program-specific

5 UNCLASSIFIED POSITIONS

- 6 Sec. 300. (1) From the funds appropriated in part 1, there is
- 7 funding to support unclassified employee positions as authorized by
- 8 section 5 of article XI of the state constitution of 1963. These
- 9 positions include the following: department director the adjutant
- 10 general for Michigan; assistant adjutant general army; assistant
- 11 adjutant general installations; assistant adjutant general air;
- 12 senior policy executive Michigan veterans affairs agency; senior
- 13 deputy director state operations; director strategy and policy;
- 14 director public safety group; and director Michigan veterans
- 15 affairs agency.
- 16 (2) Not less than 30 days prior to the department submitting a
- 17 request for an additional unclassified employee position from the
- 18 civil service commission, or for any substantive change to the
- 19 duties of an existing unclassified employee position, the
- 20 department shall notify the subcommittees and the senate and house
- 21 fiscal agencies.

22 ARMORIES AND JOINT FORCE READINESS

- Sec. 302. (1) From the funds appropriated in part 1 for
- 24 military operations, effective and efficient executive direction
- 25 and administrative leadership shall be provided to the department.
- 26 (2) The department shall operate and maintain National Guard

- 1 armories.
- 2 (3) The department shall evaluate armories and submit a
- 3 quarterly report on the status of the armories.
- 4 (4) The department shall maintain a system to measure the
- 5 condition and adequacy of the armories.
- 6 (5) The Michigan Army National Guard and Air National Guard
- 7 shall work to provide a culture that is free of sexual assault,
- 8 through an environment of prevention, education and training,
- 9 response capability, victim support, reporting procedures, and
- 10 appropriate accountability that enhances the safety and well-being
- 11 of all guard members.

12 NATIONAL GUARD TRAINING FACILITIES AND AIR BASES

- Sec. 304. (1) The department shall provide Army and Air
- 14 National Guard forces, when directed, for state and local
- 15 emergencies and in support of national military requirements.
- 16 (2) The department shall operate and maintain Army National
- 17 Guard training facilities, including Fort Custer and Camp Grayling.
- 18 (3) The department shall maintain a system that measures the
- 19 condition and adequacy of air facilities using both quality and
- 20 functionality criteria.
- 21 (4) The department shall operate and maintain Air National
- 22 Guard air bases, including Selfridge Air National Guard base,
- 23 Battle Creek Air National Guard base, and Alpena combat readiness
- 24 training center.
- 25 (5) The department shall provide the following information as
- 26 provided under section 219:
- 27 (a) The apportioned and assigned strength of the Michigan Army

- 1 National Guard.
- 2 (b) The apportioned and assigned strength of the Michigan Air
- 3 National Guard.
- 4 (c) Recruiting, retention, and attrition data, including
- 5 measurement against stated performance goals, for the Michigan Army
- 6 National Guard.
- 7 (d) Recruiting, retention, and attrition data, including
- 8 measurement against stated performance goals, for the Michigan Air
- 9 National Guard.
- 10 Sec. 305. There is hereby created and established under the
- 11 jurisdiction and control of the department a revolving account to
- 12 be known as the billeting fund account. All of the fees and other
- 13 revenues generated from the operation of the chargeable transient
- 14 quarters program shall be deposited in the billeting fund account.
- 15 Appropriations will be made from the account for the support of
- 16 program operations and the maintenance and operations of the
- 17 chargeable transient quarters program and will not exceed the
- 18 estimated revenues for the fiscal year in which they are made,
- 19 together with unexpended balances from prior years. The department
- 20 shall submit an annual report of operations and expenditures
- 21 regarding the billeting fund account to the appropriations
- 22 committees of the senate and house of representatives, the house
- 23 and senate fiscal agencies, and the state budget office at the end
- 24 of the fiscal year.

25 MICHIGAN YOUTH CHALLENGE ACADEMY

- 26 Sec. 307. (1) The department shall maintain the Michigan youth
- 27 challeNGe academy to provide values, skills, education, and self-

- 1 discipline instruction for at-risk youth as provided under 32 USC
- **2** 509.
- 3 (2) The department shall take steps to recruit candidates to
- 4 the challenge program from economically disadvantaged areas,
- 5 including those with low-income and high-unemployment backgrounds.
- 6 (3) The department shall partner with the department of human
- 7 services to identify youth who may be eligible for the challeNGe
- 8 program from those youth served by department of human services
- 9 programs. These eligible youth shall be given priority for
- 10 enrollment in the program.
- 11 (4) The department shall maintain the staffing and resources
- 12 necessary to train at least 144 cadets simultaneously at the
- 13 Michigan youth challeNGe academy.
- 14 (5) The department shall ensure that the average grade level
- 15 increase for Michigan youth challeNGe academy graduates is 2 years
- 16 as measured with the test adult basic education (TABE) metrics.

17 MILITARY FAMILY RELIEF FUND

- 18 Sec. 308. (1) The department shall provide grants for
- 19 disbursement from the military family relief fund, as provided
- 20 under the military family relief fund act, 2004 PA 363, MCL 35.1211
- 21 to 35.1216, and R 200.5 to R 200.95 of the Michigan administrative
- 22 code.
- 23 (2) The department shall provide information on the revenues,
- 24 expenditures for advertising and assistance grants, and fund
- 25 balance of the Michigan military family relief fund, as provided
- 26 under section 219.
- 27 (3) The department shall provide sufficient staffing and other

- 1 resources to provide outreach to the Michigan families of members
- 2 of the reserve component of the armed forces called into active
- 3 duty and to support the processing and approval of at least 60
- 4 grant applications this fiscal year under the Michigan military
- 5 relief fund and report those applications as provided in section
- **6** 219.

7 STARBASE GRANT

- 8 Sec. 309. The department shall maintain the starbase program
- 9 at Air National Guard facilities, as provided under 10 USC 2193b,
- 10 to improve the knowledge, skills, and interest of students in
- 11 kindergarten through twelfth grade in math, science, and
- 12 technology. The starbase program is to specifically target minority
- 13 and at-risk students for participation.

14 NATIONAL GUARD TUITION ASSISTANCE PROGRAM

- 15 Sec. 310. (1) The department shall establish and maintain a
- 16 National Guard tuition assistance program for members of the
- 17 Michigan Air and Army National Guard.
- 18 (2) The objective of the national guard tuition program is to
- 19 bolster military readiness by increasing recruitment and retention
- 20 of Michigan Air and Army National Guard service members (and to
- 21 fill federally authorized strength levels for the state), improve
- 22 the Michigan Air and Army National Guard's competitive draw from
- 23 other military enlistment options in the state, enhance the ability
- 24 of the Michigan Air and Army National Guard to compete for members
- 25 and federal dollars with surrounding states, and increase the pool
- 26 of eligible candidates within the Michigan Air and Army National
- 27 Guard to become commissioned officers.

- 1 (3) The department shall make efforts to reach the number of
- 2 Michigan Air and Army National Guard members participating in the
- 3 program to 1,000 during the third year of the program's existence.
- 4 To evaluate the effectiveness of the program, the department shall
- 5 monitor the number of new recruits and new reenlistments and the
- 6 percentage of those who become participants in the program and by
- 7 how competitively the percentage of authorized Michigan Air and
- 8 Army National Guard strength obtained—and retained—compares to the
- 9 neighboring air and army national guards from the states of
- 10 Illinois, Indiana, Ohio, and Wisconsin.

11 INFORMATION TECHNOLOGY SERVICES AND PROJECTS

- Sec. 311. The funds appropriated in part 1 for information
- 13 technology services and projects shall be used as a pass through
- 14 via an IDG to the department of technology, management, and budget
- 15 for technology services, including maintenance and repair services,
- 16 and technology projects, to maximize the operational efficiency and
- 17 effectiveness of the department.

18 MICHIGAN VETERANS AFFAIRS AGENCY

19 MICHIGAN VETERANS AFFAIRS AGENCY ADMINISTRATION

- 20 Sec. 400. (1) The MVAA agency shall provide outreach services
- 21 to Michigan veterans that advise them on the benefits to which they
- 22 are entitled, as provided under Executive Reorganization Order No.
- 23 2013-2, MCL 32.92. The MVAA shall also do the following:
- (a) Maintain the staffing partnerships and other resources
- 25 necessary to develop and operate an outreach program that will
- 26 communicate benefit eligibility information to at least 50% of

- 2 estimates, with a goal of reaching 100% and enabling 100% to access
- 3 benefit information online.
- 4 (b) Communicate veteran benefit information pertaining to the
- 5 Michigan military family relief fund, Michigan veterans' trust
- 6 fund, and DVA health, financial, and memorial benefits to which
- 7 they are entitled.
- 8 (c) Provide sufficient staffing and other resources to approve
- 9 requests for military discharge certificates (DD-214) annually.
- 10 (d) Continue the process to digitize all medical records,
- 11 military discharge documents, and burial records that are currently
- 12 on paper and microfilm.
- 13 (e) Provide a report, as provided under section 219, on the
- 14 MVAA's performance on the performance measures, outcomes, and
- 15 initiatives developed by the agency in the strategic plan required
- 16 by section 501 of 2013 PA 9.
- 17 (f) Provide a report to the subcommittees, senate and house
- 18 fiscal agencies, and the state budget office no later than April 1
- 19 providing for the following:
- 20 (i) To the extent known, data on the estimated number of
- 21 homeless veterans, by county, in this state.
- 22 (ii) A summary of the activities and strategies developed to
- 23 date under the MVAA community assessment and regional service
- 24 delivery model pilot.
- 25 (2) From the funds appropriated in part 1, the MVAA shall
- 26 provide for the regional coordination of services, as follows:
- 27 (a) Regional coordinators shall be selected by the MVAA

- 1 through a grant agreement with VSOs or by other means.
- 2 (b) Regional coordinators shall provide the following
- 3 services:
- 4 (i) Coordinate veteran benefit counselors' efforts throughout

- 22 (b) Maintain the staffing and resources necessary to process a
- 23 minimum of 500 claims per year.
- 24 (4) The MVAA shall maintain staffing and resources necessary
- 25 to develop and implement a process to ensure that all county
- 26 counselors receive the training and accreditation necessary to
- 27 provide quality services to our veterans. The MVAA shall report

- 23 separately for each service region, the amount of expenditures to
- 24 date, number of service hours, number of claims for benefits
- 25 submitted by type of claim, and other information deemed

- 1 year 2015-2016, excluding appropriations designated as 1-time
- 2 appropriations and adjusting for changes in caseload and related

- 4 revenue. These adjustments will be determined after the January
- 5 2016 consensus revenue estimating conference.
