6 Sec. 201. In accordance with the provisions of section 30 of				
7	article IX of the state constitution of 1963, total state spending			
8	from state resources in this appropriation act for the fiscal year			
9	ending September 30, 2018 is \$18,650,000.00 and total state			
10	spending from state sources to be paid to local units of government			
11	is \$18,000,000.00.			
12	Sec. 202. The appropriations authorized under this act are			
13	subject to the management and budget act, 1984 PA 431, MCL 18.1101			
14	to 18.1594.			
15	DEPARTMENT OF STATE POLICE			
16	Sec. 301. (1) Funding appropriated in part 1 for the school			
17	safety initiative shall be used to provide and administer			
18	competitive grants to public or nonpublic schools, school			
19	districts, and intermediate school districts to purchase technology			

and equipment and to conduct school building safety assessments to

improve the safety and security of school buildings, students, and

school staff. The department of state police, grants and community

services division, shall administer the grant program described in

this section.

- 1 (2) The goal of the grant program is to create a safer school
- 2 environment through equipment and technology enhancements.
- 3 (3) Applications shall be accepted directly from public or
- 4 nonpublic schools, school districts, and intermediate school
- 5 districts. School district and intermediate school district
- 6 applications are required to be for buildings that have pre-K to 12
- 7 classrooms and students. There is a limit of 1 application per
- 8 eligible applicant. Individual schools may submit their own
- 9 application but must not also be included in a school district
- 10 application if they submitted an individual application. All grants
- 11 shall be funded on a reimbursement-only basis.
- 12 (4) From the funds appropriated in part 1 for school safety
- initiative, \$5,000,000.00 shall be made available, subject to the
- 14 requirements of subsection (3), to individual public or nonpublic
- 15 schools, school districts, and intermediate school districts.
- 16 Applications are limited to \$25,000.00 per application for
- 17 individual schools and \$250,000.00 for school districts or
- 18 intermediate school districts.
- 19 (5) From the funds appropriated in part 1 for school safety
- 20 initiative, \$10,000,000.00 shall be made available, subject to the
- 21 requirements of subsection (3), to individual public or nonpublic
- 22 schools, school districts, and intermediate school districts. There
- 23 shall be no limitation on the amount applied for but the applicant
- 24 must provide a 25% match in order to qualify for the funds.
- 25 (6) Applications shall be selected for funding based on
- 26 eligibility, the project description and whether the project
- 27 reflects the highest security need of the applicant within grant

- 1 funding constraints, the budget narrative, the budget, project
- 2 goals, objectives, and performance measures. Priority shall be
- 3 given to projects that involve multiple agencies working in
- 4 partnership, to proposals that seek to secure exterior access
- 5 points of school buildings, and to those applicants that did not
- 6 receive a school safety initiative grant in the past. Grant
- 7 applicants must demonstrate proof that a school has an emergency
- 8 operations plan that had been updated after August 1, 2014, to
- 9 align with the state of Michigan emergency operations plan guidance
- 10 and include a signed letter of support from the chief local law
- 11 enforcement official.
- 12 (7) Eligible expenditures under school safety initiative
- 13 grants include 1 or more of the following:
- 14 (a) Physical security enhancement equipment, such as door
- 15 locks, proximity access card readers, keypads, motion detection
- 16 systems, lighting, closed-circuit television systems, and video
- 17 intercom devices.
- 18 (b) Improve exterior access points of school buildings.
- 19 (c) Public address systems.
- 20 (d) Inspection and screening systems.
- 21 (e) Shatterproof glass or film for exterior doors or windows.
- 22 (f) Signs, such as "Emergency Exit Only" and "Visitors
- 23 Register at Front Office" signs.
- 24 (q) Fences and gates.
- (h) School safety assessment.
- 26 (8) The following items shall not be eligible for grant
- 27 expenditure:

- 1 (a) Weapons, including tasers.
- 2 (b) Personal body armor for routine use.
- 3 (c) Construction of new facilities.
- 4 (d) Costs in applying for this grant, such as consultants and
- 5 grant writers.
- 6 (e) Expenses incurred prior to the date of the award or after
- 7 the end of the grant performance period.
- 8 (f) Personnel costs.
- 9 (g) Indirect costs or indirect administrative expenses.
- 10 (h) All travel, including first class or out-of-state travel.
- 11 (i) Contributions or donations.
- 12 (j) Management or administrative training and conferences,
- 13 except as otherwise pre-approved by the department of state police.
- 14 (k) Management studies or research and development.
- 15 (1) Memberships and dues, unless a specific requirement of the
- 16 project that has been pre-approved by the department of state
- 17 police.
- 18 (m) Vehicles, watercraft, or aircraft, including unmanned or
- 19 remotely piloted aircraft and vehicles.
- 20 (n) Service contracts and training beyond the performance
- 21 period of the grant award.
- (o) Food, refreshments, and snacks.
- 23 (9) The department shall issue grant guidance and application
- 24 materials, including required performance measures, no later than
- 25 July 1, 2018 and shall issue awards no later than October 31, 2018.
- 26 A project must be completed by March 1, 2019.
- 27 (10) The department of state police shall report on grant

- 1 activities to the house and senate appropriations subcommittees on
- 2 state police and the state budget office by December 31, 2018,
- 3 including performance outcomes as identified in individual grant
- 4 agreements.
- 5 Sec. 302. (1) From the funds appropriated for the school
- 6 emergency notification system, \$3,000,000.00 shall be used to
- 7 expand the existing advanced 9-1-1 contract for the sole purpose of
- 8 implementing a statewide K-12 << >> school panic button app system
- 9 in support of <<pre>cpublic and non-public schools>>. The phone
- 10 application based system must allow authorized users to
- 11 simultaneously place a voice call to 9-1-1 while also providing
- 12 intelligent notifications via text, electronic mail, and push
- 13 notifications to relevant communities to which the users belong,
- 14 key stakeholders, and authorized users including school staff,
- 15 school resource officers, 9-1-1, and first responder agencies based
- 16 on the location and category of emergency event. These
- 17 notifications shall contain information regarding the identity of
- 18 the reporting party, his or her location, type of response required
- 19 based on incident type, and additional location details. The system
- 20 must also allow 9-1-1, school officials, and first responder
- 21 agencies to send messages to panic button app users both during and
- 22 after emergency events in order to facilitate ongoing
- 23 communications and coordination.
- 24 (2) The school emergency notification system must also
- 25 integrate with the state's current supplemental 9-1-1 database,
- 26 containing information voluntarily provided by individuals and
- 27 facility managers via a secure web application. Any information

- 1 submitted by K-12 schools under that program, including items such
- 2 as floor plans, automated external defibrillator information,
- 3 school safety plans, reunification plans, and entry or exit points,
- 4 should automatically present itself to 9-1-1 anytime the panic
- 5 button app is activated.
- 6 (3) The appropriation described in this section is for the
- 7 purpose of defraying the initial costs associated with
- 8 implementation of the secure schools program, including
- 9 installation, training, and maintenance costs. Funds will be
