## SUBSTITUTE FOR HOUSE BILL NO. 4001

A bill to amend 2014 PA 138, entitled "Workforce opportunity wage act,"

by amending sections 4 and 4b (MCL 408.414 and 408.414b); and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 4. (1) Subject to the exceptions specified in this act, the minimum hourly wage rate is:
- 3 (a) Before September 1, 2014, \$7.40.
- 4 (b) Beginning September 1, 2014, \$8.15.
- 5 (c) Beginning January 1, 2016, \$8.50.
- 6 (d) Beginning January 1, 2017, \$8.90.
- 7 (e) Beginning January 1, 2018, \$9.25.
- 8 (a) Beginning February 21, 2025, \$12.00.





- 1 (b) Beginning January 1, 2026, \$12.50.
- 2 (c) Beginning January 1, 2027, \$13.00.
- 3 (d) Beginning January 1, 2028, \$14.00.
  - (e) Beginning January 1, 2029, \$15.00.
- 5 (2) Every January beginning in January 2019, 2030, the state
- 6 treasurer shall adjust the minimum wage by an amount determined by
- 7 the state treasurer at the end of the **immediately** preceding
- 8 calendar year to reflect the average annual percentage change in
- 9 the consumer price index Consumer Price Index for the most recent
- 10 5-year period for which data are available. As used in this
- 11 subsection, "consumer price index" "Consumer Price Index" means the
- 12 most comprehensive index of consumer prices available for the
- 13 midwest region from the bureau Bureau of labor statistics Labor
- 14 Statistics of the United States department Department of labor.
- 15 **Labor.** The wage and hours division of the department of licensing
- 16 and regulatory affairs shall post the adjusted minimum wage on its
- 17 website by not later than February 1 of the year it is calculated,
- 18 and the adjusted rate is effective beginning April 1 of that year.
- 19 An annual increase under this subsection shall must not exceed
- 20 3.5%.

- 21 (3) An increase in the minimum hourly wage rate as prescribed
- 22 in subsection (2) does not take effect if the unemployment rate
- 23 determined by the bureau of labor statistics, Labor
- 24 Statistics of the United States department Department of labor,
- 25 **Labor**, for this state is 8.5% 7.5% or greater more for the year
- 26 preceding the year of the prescribed increase.
- Sec. 4b. (1) An employer may pay a new employee who is less
- 28 than 20 years of age a training hourly wage of \$4.25 that is 75% of
- 29 the general minimum hourly wage established under section 4 for the

- 1 first 90 days of that employee's employment. The hourly wage
- 2 authorized under this subsection is in lieu of the minimum hourly
- 3 wage otherwise prescribed by this act.
- 4 (2) Except as provided in subsection (1), the The minimum
- 5 hourly wage for an employee who is less than 18 years of age is 85%
- 6 75% of the general minimum hourly wage established in under section
- 7 4.
- 8 (3) An employer shall not displace an employee to hire an
- 9 individual at the hourly wage authorized under this section. As
- 10 used in this subsection, "displace" includes termination of
- 11 employment or any reduction of hours, wages, or employment
- 12 benefits.
- 13 (4) A person who violates subsection (3) is subject to a civil
- 14 fine of not more than \$1,000.00.
- 15 Enacting section 1. The improved workforce opportunity wage
- 16 act, 2018 PA 337, MCL 408.931 to 408.945, is repealed.
