A bill to amend Act No 218 of the Public Acts of 1956, entitled as amended

The insurance code of 1956

as amended being sections 500 100 to 500 8302 of the Michigan Compiled Laws, by adding sections 2027a, 2111a, 2115a and 3356

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Act No 218 of the Public Acts of 1956, as
- 2 amended being sections 500 100 to 500 8302 of the Michigan
- 3 Compiled Laws, is amended by adding sections 2027a 2111a 2115a
- 4 and 3356 to read as follows
- 5 SEC 2027A (1) IT IS AN UNFAIR METHOD OF COMPETITION AND
- 6 AN UNFAIR OR DECEPTIVE ACT OR PRACTICE IN THE BUSINESS OF INSUR-
- 7 ANCE FOR A PRIVATE PASSENGER NONFLEET AUTOMOBILE INSURER TO DO
- 8 ANY OF THE FOLLOWING

- (A) PROVIDE AN INCENTIVE OR DISINCENTIVE TO AN AGENT THE
- 2 LIFECT OF WHICH DISCOURAGES THAT AGENT FROM SELLING AUTOMOBILE
- 3 INSURANCE IN A GEOGRAPHIC AREA
- 4 (B) BASE MARKETING OF AUTOMOBILE INSURANCE, IN WHOLE OR IN
- 5 PART ON ANY OF THE FOLLOWING FOR THE APPLICANT FOR INSURANCE

- 26 TION ABOUT THE INSURER S AUTOMOBILE INSURANCE RATES AND TO DIRECT

- I RESIDENTS IO THE INSURLE S AUTOMOBILE INSURANCE AGENT LOCATED
- 2 NEAREST TO THE RESIDENT
- 3 SEC 3356 (1) AMOUNTS PAID BY THE FACILITY THAT ARE AGENT
- 4 COMMISSION PAYMENTS OR ARE PAID AS A RESULT OF THE SALE OF AUTO-
- 5 MOBILE INSURANCE COVERAGE PLACED THROUGH THE FACILITY SHALL BE
- 6 PAID TO THE AGENT WHO SOLD THE COVERAGE UPON WHICH THE PAYMENT
- 7 WAS BASED
- 8 (2) AMOUNTS PAID UNDER SUBSECTION (1) SHALL NOT BE RETAINED
- 9 BY AN INSURER OR USED FOR ANY PURPOSE OTHER THAN AS PROVIDED IN
- 10 SUBSECTION (1)
