## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Act No 368 of the Public Acts of 1978 as
- 2 amended being sections 333 1101 to 333 25211 of the Michigan
- 3 Compiled Laws, is amended by adding section 21720c to read as
- 4 follows
- 5 SEC 21720C (1) UPON AN OFFER OF INITIAL EMPLOYMENT BEING
- 6 MADE BY A NURSING HOME TO AN INDIVIDUAL FOR A NURSING PERSONNEL
- 7 POSITION, THE NURSING HOME SHALL REQUEST FROM THE CRIMINAL
- 8 RECORDS DIVISION OF THE DEPARTMENT OF STATE POLICE A CRIMINAL
- 9 HISTORY CHECK ON THE INDIVIDUAL AND BEFORE EMPLOYING THE

- 1 INDIVIDUAL AS A REGULAR EMPLOYEE, SHALL HAVE RECEIVED FROM THE

- 13 (4) WITHIN 30 DAYS AFTER RECEIVING A PROPER REQUEST FROM A

- 15 THIS SECTION, THE CRIMINAL RECORDS DIVISION OF THE DEPARTMENT OF

- 22 (5) CRIMINAL HISTORY RECORD INFORMATION RECEIVED FROM THE
- 23 CRIMINAL RECORDS DIVISION OF THE DEPARTMENT OF STATE POLICE UNDER
- 24 SUBSECTION (4) SHALL BE USED BY A NURSING HOME ONLY FOR THE PUR-
- 25 POSE OF EVALUATING AN APPLICANT S QUALIFICATIONS FOR EMPLOYMENT
- 26 IN THE POSITION FOR WHICH HE OR SHE HAS APPLIED A NURSING HOME
- 27 ADMINISTRATOR OR OTHER NURSING HOME EMPLOYEE SHALL NOT DISCLOSE

- 1 THE REPORT OR ITS CONTENTS, EXCEPT ANY FELONY CONVICTION OR A
- 2 MISDEMEANOR CONVICTION INVOLVING SEXUAL OR PHYSICAL ABUSE, TO ANY
- 3 PERSON WHO IS NOT DIRECTLY INVOLVED IN EVALUATING THE APPLICANT S
- 4 QUALIFICATIONS FOR EMPLOYMENT A PERSON WHO VIOLATES THIS SUB-
- 5 SECTION IS GUILTY OF A MISDEMEANOR PUNISHABLE BY A FINE OF NOT
- 6 MORE THAN \$10,000 00
- 7 (6) AS USED IN THIS SECTION, CRIMINAL HISTORY RECORD
- 8 INFORMATION MEANS THAT TERM AS DEFINED IN SECTION 1A OF ACT
- 9 NO 289 OF THE PUBLIC ACTS OF 1925, BEING SECTION 28 241A OF THE
- 10 MICHIGAN COMPILED LAWS
