ENROLLED SENATE BILL No. 426

AN ACT to make appropriations to the department of natural resources; to provide for the acquisition of land; to provide for the development of public recreation facilities; to prescribe the powers of certain state agencies, officers, and employees; to provide for the expenditure of appropriations; to make appropriations for the department of natural resources and for local recreation grants for the fiscal year ending September 30, 1995; to prescribe the powers and duties of certain state agencies and officials; and to provide for the expenditure of the appropriations.

The People of the State of Michigan enact:

NATURAL RESOURCES TRUST FUND

Sec. 1. There is appropriated for the department of natural resources to supplement former appropriations for the fiscal year ending September 30, 1995, the sum of \$19,723,300.00 for land acquisition and grants and \$4,470,700.00 for public recreation facility development and grants as provided in section 35 of article IX of the state constitution of 1963 and part 19 of the natural resources and environmental protection act, Act No. 451 of the Public Acts of 1994, being sections 324.1901 to 324.1910 of the Michigan Compiled Laws, from the following funds:

Sec. 3. The department of natural resources shall enter into agreements with local units of government for the purpose of administering the grants identified in section 1. Among other provisions, the agreements shall require that grant recipients agree to dedicate to public recreation uses in perpetuity the land acquired; to replace lands converted or lost to other than public recreation use; and to convey to the state any mineral interests acquired by the grant recipient with an exception allowed for a share of the mineral interests acquired, which share is based on the portion of the fair market value of the property that was provided by the local cash contribution of the grant recipient. The

agreements shall also provide the full payments of grants be made only after proof of acquisition is submitted by the grant recipient and all costs are verified by the department of natural resources.

Sec. 4. The department of natural resources shall take steps necessary to make available federal or other funds that may become available for the purpose for which appropriations are made in section 1, and to use any or all of the appropriations to meet matching requirements which are determined to be in the best interest of the state.

Sec. 5. Any unobligated balance in any appropriation made under section 1 shall not revert to the fund from which appropriated at the close of the fiscal year, but shall continue until the purpose for which it was appropriated is completed. The unexpended balance of any appropriation made in section 1 remaining after the purpose for which it was appropriated is completed shall revert to the Michigan natural resources trust fund and be made available for appropriation.

Sec. 6. If a person or organization has acquired an option on a parcel of property prior to final determination by the department of natural resources and the Michigan natural resources trust fund board, the property shall not be considered for acquisition unless the department and board can demonstrate that a clear recreational advantage exists in obtaining the parcel of property for the people of the state at a reasonable fair market value.

Sec. 7. As required by section 1903(3) of the natural resources and environmental protection act, Act No. 451 of the Public Acts of 1994, being section 324.1903 of the Michigan Compiled Laws, the grants-in-aid to local units of government shall be awarded pursuant to this act.

Sec. 8. The appropriation in section 1. A. (priority no. 10) for boating lump sum access sites acquisition (#94-311) shall not be expended for land acquisition on a lake not specifically identified.

Sec. 9. Before any funds appropriated in section 1 for boating access sites may be expended, and by October 1, 1995, the department shall submit to the joint capital outlay subcommittee the department of natural resources' policy in acquisition of boating access site properties that will include, but not be limited to, the following criteria:

- (a) Lake size and lake depth.
- (b) Existing publicly owned facilities.
- (c) Potential for recreational boating opportunities, including hunting and fishing activities.
- (d) Proximity to population.
- (e) Proximity to public road system.
- (f) Availability of other public access sites within a 15-mile radius.
- (g) Existing shoreline development.

Sec. 202. The appropriations made and expenditures authorized under this act and the departments, agencies, commissions, boards, offices, and programs for which an appropriation is made under this act are subject to the management and budget act, Act No. 431 of the Public Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

Sec. 203. For all projects and grant programs funded under this act, the commission of natural resources or the department of natural resources shall notify each legislator whose district is to receive a grant 7 days before the grants are announced.

Sec. 204. It is the intent of the legislature that the state shall make bonds issued pursuant to the environmental protection bond implementation act, Act No. 328 of the Public Acts of 1988, being sections 299.671 to 299.685 of the Michigan Compiled Laws, available to the citizens of the state by making a portion of the bonds available in denominations of \$500.00 or less, and shall otherwise encourage the participation of the citizens of the state in the investment in environmental protection bonds.

Sec. 205. (1) The unexpended portion of the appropriation in section 101 for local recreational grants projects in this act and Act No. 55 of the Public Acts of 1990, Act No. 194 of the Public Acts of 1990, Act No. 30 of the Public Acts of 1991, Act No. 83 of the Public Acts of 1992, Act No. 74 of the Public Acts of 1993, and Act No. 134 the Public Acts of 1994 are considered work project appropriations and any unencumbered or unallotted funds are carried forward into the succeeding fiscal year. The following is in compliance with section 451(3) of the management and budget act, Act No. 431 of the Public Acts of 1984, being section 18.1451 of the Michigan Compiled Laws.

(2) For each of the projects described in subsection (1):

(a) The purpose of the local recreational grant to be carried forward is to improve the development of the state's recreational base.

(b) The project will be accomplished by contract.

(c) The total estimated costs of the project are identified in a line item appropriation.

(d) The tentative completion date for the project is September 30, 1998.

Sec. 206. In response to a request from a sanitary sewer authority, village, township, or county to participate in a sanitary sewer project, the department shall conduct a feasibility study. The study shall include, but not be limited to, the capital costs and benefits of participating in the requested project against the present and future capacity and costs of not participating in the requested project.
