A bill to amend Act No. 350 of the Public Acts of 1980, entitled as amended

"The nonprofit health care corporation reform act,"
as amended, being sections 550.1101 to 550.1704 of the Michigan
Compiled Laws, by adding section 418.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 350 of the Public Acts of 1980, as

- 3 Compiled Laws, is amended by adding section 418 to read as
- 4 follows:
- 5 SEC. 418. (1) A HEALTH CARE CORPORATION SHALL OFFER TO PRO-
- 6 VIDE BENEFITS TO A SUBSCRIBER FOR THE SUBSCRIBER'S CHILD UNDER
- 7 THE SUBSCRIBER'S CERTIFICATE UNTIL DECEMBER 31 OF THE CALENDAR
- 8 YEAR IN WHICH THE CHILD BECOMES 21 YEARS OF AGE IF ALL OF THE
- 9 FOLLOWING ARE MET:

- 1 (A) THE CHILD IS A CHILD BY BIRTH OR ADOPTION OF THE
- 2 SUBSCRIBER.
- 3 (B) THE CHILD IS CONSIDERED A DEPENDENT UNDER SECTION 152 OF

- 5 (C) THE CHILD IS UNMARRIED.
- 6 (2) A HEALTH CARE CORPORATION SHALL OFFER TO PROVIDE BENE-
- 7 FITS TO A SUBSCRIBER FOR THE SUBSCRIBER'S CHILD UNDER THE
- 8 SUBSCRIBER'S CERTIFICATE UNTIL DECEMBER 31 OF THE CALENDAR YEAR
- 9 IN WHICH THE CHILD BECOMES 25 YEARS OF AGE IF ALL OF THE FOLLOW-
- 10 ING ARE MET:
- (A) THE CHILD IS A CHILD BY BIRTH OR ADOPTION OF THE
- 12 SUBSCRIBER.
- (B) THE CHILD IS CONSIDERED A DEPENDENT UNDER SECTION 152 OF
- 14 THE INTERNAL REVENUE CODE OF 1986, 26 U.S.C. 152.
- (C) THE CHILD IS ENROLLED AS A FULL-TIME OR PART-TIME STU-
- 16 DENT IN AN EDUCATIONAL OR VOCATIONAL TRAINING PROGRAM.
- (D) THE CHILD IS UNMARRIED.
