

HOUSE BILL No. 4735

April 25, 1995, Introduced by Reps. Willard, Freeman, Gire, Ciaramitaro, Gubow, Price and Olshove and referred to the Committee on Appropriations.

A bill to amend Act No. 270 of the Public Acts of 1984, entitled

"Michigan strategic fund act,"

as amended, being sections 125.2001 to 125.2093 of the Michigan Compiled Laws, by adding sections 15 and 16.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 270 of the Public Acts of 1984, as
- 2 amended, being sections 125.2001 to 125.2093 of the Michigan
- 3 Compiled Laws, is amended by adding sections 15 and 16 to read as
- 4 follows:
- 5 SEC. 15. EXCEPT AS OTHERWISE PROVIDED BY LAW, ANY PERSON OR
- 6 MUNICIPALITY THAT RECEIVES A GRANT, LOAN, LOAN INSURANCE, OR
- 7 GUARANTEE UNDER THIS ACT FOR A PROJECT SHALL EMPLOY MICHIGAN
- 8 RESIDENTS OR CONTRACT WITH AN ENTITY THAT EMPLOYS MICHIGAN
- 9 RESIDENTS TO WORK ON THAT PROJECT UNLESS THE BOARD MAKES A

- 1 WRITTEN DETERMINATION THAT EMPLOYING NON-MICHIGAN RESIDENTS OR
- 2 CONTRACTING WITH AN ENTITY THAT EMPLOYS NON-MICHIGAN RESIDENTS IS
- 3 NECESSARY FOR THE TIMELY COMPLETION OF THE PROJECT AND THAT THERE
- 4 ARE NO MICHIGAN RESIDENTS OR ENTITIES THAT EMPLOY MICHIGAN RESI-
- 5 DENTS AVAILABLE TO WORK ON THE PROJECT.
- 6 SEC. 16. EXCEPT AS OTHERWISE PROVIDED BY LAW, ANY PERSON OR
- 7 MUNICIPALITY THAT RECEIVES A GRANT, LOAN, LOAN INSURANCE, OR
- 8 GUARANTEE UNDER THIS ACT FOR A PROJECT SHALL COMPETITIVELY BID
- 9 ALL GOODS AND SERVICES USED IN THE PROJECT UNLESS THE BOARD MAKES
- 10 A WRITTEN DETERMINATION THAT ANOTHER FORM OF PROCUREMENT IS
- 11 NECESSARY. THE COMPETITIVE BIDDING PROCESS SHALL BE OPEN TO ALL
- 12 MICHIGAN RESIDENTS AND MICHIGAN BUSINESSES.
