

HOUSE BILL No. 5155

September 26, 1995, Introduced by Rep. Clack and referred to the Committee on Regulatory Affairs.

A bill to amend section 4 of Act No. 454 of the Public Acts of 1978, entitled

"Truth in renting act,"

being section 554.634 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 4 of Act No. 454 of the Public Acts of
- 2 1978, being section 554.634 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 4. (1) A rental agreement shall state the name and
- 5 address at which notice required under this act shall be given to
- 6 the lessor.
- 7 (2) A rental agreement shall state in a prominent place in
- 8 type not smaller than the size of 12-point type, or in legible
- 9 print with letters not smaller than 1/8 inch, a notice in
- 10 substantially the following form:

- 1 "NOTICE: Michigan law establishes rights and obligations
- 2 for parties to rental agreements. This agreement is required to
- 3 comply with the Truth in Renting Act. If you have a question
- 4 about the interpretation or legality of a provision of this
- 5 agreement, you may want to seek assistance from a lawyer or other
- 6 qualified person.".
- 7 (3) A RENTAL AGREEMENT SHALL PROVIDE A NOTICE THAT THE RESI-
- 8 DENTIAL PREMISES MAY BE SUBJECT TO LEAD HAZARDS. THE NOTICE
- 9 SHALL PROVIDE A SPACE TO INDICATE WHETHER THE RESIDENTIAL
- 10 PREMISES ARE WITHIN A TARGET AREA AS DEFINED IN THE LEAD ABATE-
- 11 MENT ACT AND WHETHER LEAD ABATEMENT HAS OCCURRED IN THE RESIDEN-
- 12 TIAL PREMISES. THE LESSOR SHALL PROVIDE TO A LESSEE A COPY OF
- 13 THE RULES PROMULGATED BY THE DEPARTMENT OF PUBLIC HEALTH UNDER
- 14 THE LEAD ABATEMENT ACT REGARDING LEAD-BASED PAINT HAZARDS.
- 15 (4) THE NOTICE REQUIRED UNDER SUBSECTION (3) MAY BE PROVIDED
- 16 ON A SEPARATE DOCUMENT ATTACHED TO THE RENTAL AGREEMENT.
- 17 Section 2. This amendatory act shall not take effect unless
- 18 House Bill No. 4011 of the 88th Legislature is enacted into law.
