

HOUSE BILL No. 5502

January 16, 1996, Introduced by Rep. Bodem and referred to the Committee on Tourism and Recreation.

A bill to amend Act No. 451 of the Public Acts of 1994, entitled

"Natural resources and environmental protection act," as amended, being sections 324.101 to 324.90106 of the Michigan Compiled Laws, by adding part 831.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 451 of the Public Acts of 1994, as
- 2 amended, being sections 324.101 to 324.90106 of the Michigan
- 3 Compiled Laws, is amended by adding part 831 to read as follows:
- 4 SUBCHAPTER 7 FOREST RECREATION
- 5 PART 831 STATE FOREST RECREATION
- 6 SEC. 83101. AS USED IN THIS PART:
- 7 (A) "CONCESSION" MEANS AN AGREEMENT BETWEEN THE DEPARTMENT
- 8 AND A PERSON UNDER TERMS AND CONDITIONS AS SPECIFIED BY THE

- I DEPARTMENT TO PROVIDE SERVICES OR RECREATIONAL OPPORTUNITIES FOR
- 2 PUBLIC USE.
- 3 (B) "FUND" MEANS THE FOREST RECREATION FUND CREATED IN SEC-
- 4 TION 83104.
- 5 (C) "LEASE" MEANS A CONVEYANCE BY THE DEPARTMENT TO A PERSON
- 6 OF A PORTION OF THE STATE'S INTEREST IN LAND UNDER SPECIFIC TERMS
- 7 AND FOR VALUABLE CONSIDERATION, THEREBY GRANTING TO THE LESSEE
- 8 THE POSSESSION OF THAT PORTION CONVEYED DURING THE PERIOD
- 9 STIPULATED.
- 10 (D) "STATE FOREST" MEANS THOSE LANDS DESIGNATED AS STATE
- II FORESTS BY THE DEPARTMENT.
- 12 SEC. 83102. THE DEPARTMENT SHALL DEVELOP, OPERATE, MAIN-
- 13 TAIN, AND PROMOTE AN INTEGRATED RECREATION SYSTEM THAT PROVIDES
- 14 OPPORTUNITIES FOR HUNTING, FISHING, CAMPING, HIKING, SNOWMOBIL-
- 15 ING, BOATING, TRAIL RELATED ACTIVITIES, AND OTHER FORMS OF RECRE-
- 16 ATION WITHIN EACH STATE FOREST.
- 17 SEC. 83103. (1) IN IMPLEMENTING SECTION 83102, THE DEPART-
- 18 MENT MAY DO ANY OF THE FOLLOWING:
- (A) ENTER INTO CONTRACTS OR AGREEMENTS WITH A PERSON AS MAY
- 20 BE NECESSARY TO IMPLEMENT THIS PART.
- 21 (B) GRANT CONCESSIONS WITHIN THE BOUNDARIES OF A STATE
- 22 FOREST TO A PERSON. IN GRANTING A CONCESSION, THE DEPARTMENT
- 23 SHALL PROVIDE THAT EACH CONCESSION IS AWARDED AT LEAST EVERY 7
- 24 YEARS BASED ON EXTENSION, RENEGOTIATION, OR COMPETITIVE BIDDING.
- 25 (C) LEASE PROPERTY TO A PERSON.

- 1 (D) ACCEPT GIFTS, GRANTS, OR BEQUESTS FROM ANY PUBLIC OR
- 2 PRIVATE SOURCE OR FROM THE FEDERAL GOVERNMENT OR A LOCAL UNIT OF
- 3 GOVERNMENT FOR FURTHERING THE PURPOSES OF THIS PART.
- 4 (2) UNLESS OTHERWISE PROVIDED BY STATE OR FEDERAL LAW, ALL
- 5 MONEY COLLECTED UNDER THIS SECTION SHALL BE DEPOSITED INTO THE
- 6 FUND.
- 7 SEC. 83104. (1) THE FOREST RECREATION FUND IS CREATED
- 8 WITHIN THE STATE TREASURY.
- 9 (2) THE FUND MAY RECEIVE MONEY AS PROVIDED IN THIS PART AND
- 10 FROM ANY OTHER SOURCE. THE STATE TREASURER SHALL DIRECT THE
- 11 INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT TO THE
- 12 FUND INTEREST AND EARNINGS FROM THE FUND INVESTMENTS. MONEY
- 13 REMAINING IN THE FUND AT THE END OF A FISCAL YEAR SHALL BE CAR-
- 14 RIED OVER IN THE FUND TO THE NEXT AND SUCCEEDING FISCAL YEAR.
- 15 (3) MONEY IN THE FUND SHALL BE USED BY THE DEPARTMENT TO
- 16 DEVELOP, MAINTAIN, OPERATE, AND PROMOTE FOREST RECREATION ACTIVI-
- 17 TIES AND TO IMPLEMENT THIS PART.
- 18 SEC. 83105. (1) THE DEPARTMENT MAY APPOINT PERSONS TO FUNC-
- 19 TION AS VOLUNTEERS FOR THE PURPOSE OF FACILITATING FOREST RECRE-
- 20 ATION ACTIVITIES. WHILE A VOLUNTEER IS SERVING IN SUCH A CAPAC-
- 21 ITY, THE VOLUNTEER HAS THE SAME IMMUNITY FROM CIVIL LIABILITY AS
- 22 A DEPARTMENT EMPLOYEE AND SHALL BE TREATED IN THE SAME MANNER AS
- 23 AN EMPLOYEE UNDER SECTION 8 OF ACT NO. 170 OF THE PUBLIC ACTS OF
- 24 1964, BEING SECTION 691.1408 OF THE MICHIGAN COMPILED LAWS.
- 25 (2) A VOLUNTEER UNDER SUBSECTION (1) SHALL NOT CARRY A FIRE-
- 26 ARM WHEN FUNCTIONING AS A VOLUNTEER.

- 1 SEC. 83106. (1) THE DEPARTMENT MAY REQUIRE A PERSON TO
- 2 OBTAIN A PERMIT FOR CAMPING IN DESIGNATED STATE FOREST
- 3 CAMPGROUNDS AND MAY ESTABLISH AND COLLECT A FEE FOR THE CAMPING
- 4 PERMIT.
- 5 (2) THE DEPARTMENT MAY REQUIRE A PERSON TO OBTAIN A PERMIT,
- 6 EXCEPT AS OTHERWISE PROVIDED BY LAW, FOR THE USE OF LANDS AND
- 7 FACILITIES WITHIN THE STATE FOREST AS DESIGNATED BY THE DEPART-
- 8 MENT FOR RECREATION USE. THE DEPARTMENT MAY ESTABLISH AND COL-
- 9 LECT A FEE FOR PERMITS ISSUED UNDER THIS SUBSECTION. HOWEVER, AT
- 10 LEAST 6 MONTHS PRIOR TO THE IMPOSITION OF A FEE OR INCREASE OF A
- 11 FEE UNDER THIS SUBSECTION FOR A PARTICULAR USE OR ACTIVITY WITHIN
- 12 A STATE FOREST, THE DEPARTMENT SHALL PROVIDE PUBLIC NOTICE OF THE
- 13 FEE OR INCREASE IN THE FEE TO THE GENERAL PUBLIC AND SHALL NOTIFY
- 14 IN WRITING THE STANDING COMMITTEES OF THE LEGISLATURE THAT HAVE
- 15 JURISDICTION OVER ISSUES PRIMARILY RELATED TO NATURAL RESOURCES
- 16 AND THE ENVIRONMENT.
- 17 (3) MONEY COLLECTED UNDER THIS SECTION SHALL BE DEPOSITED
- 18 INTO THE FUND.
- 19 SEC. 83107. TO ENSURE COMPLIANCE WITH THIS PART, RULES
- 20 PROMULGATED UNDER THIS PART AND THIS ACT, INCLUDING THE STATE
- 21 LAND USE RULES PROVIDED IN R 299.331 TO R 299.335 OF THE MICHIGAN
- 22 ADMINISTRATIVE CODE, AND ANY ORDERS OF THE DIRECTOR, THE DIRECTOR
- 23 MAY COMMISSION STATE FOREST OFFICERS TO ENFORCE WITHIN THE BOUND-
- 24 ARIES OF THE STATE FOREST THESE RULES AND ANY LAWS OF THIS STATE
- 25 SPECIFIED IN THOSE RULES AS ENFORCEABLE BY COMMISSIONED STATE
- 26 FOREST OFFICERS. IN PERFORMING THOSE ENFORCEMENT ACTIVITIES,
- 27 COMMISSIONED STATE FOREST OFFICERS ARE VESTED WITH THE POWERS,

- 1 PRIVILEGES, PREROGATIVES, AND IMMUNITIES CONFERRED UPON PEACE
- 2 OFFICERS UNDER THE LAWS OF THIS STATE.
- 3 SEC. 83108. THE DEPARTMENT MAY PROMULGATE RULES TO IMPLE-
- 4 MENT THIS PART.
- 5 SEC. 83109. A VIOLATION OF THIS PART OR A RULE PROMULGATED
- 6 UNDER THIS PART IS A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR
- 7 NOT MORE THAN 90 DAYS OR A FINE OF NOT MORE THAN \$500.00, OR
- 8 BOTH.
- 9 Section 2. This amendatory act shall not take effect unless
- 10 Senate Bill No. or House Bill No. 5503 (request
- 11 no. 05781'95 a) of the 88th Legislature is enacted into law.
