

## **HOUSE BILL No. 5616**

February 21, 1996, Introduced by Rep. Kukuk and referred to the Committee on Regulatory Affairs.

A bill to amend sections 2, 3, 6, 7, 8, 10, 13, and 14 of Act No. 74 of the Public Acts of 1970, entitled as amended "Corner recordation act,"

sections 2, 6, 8, 13, and 14 as amended by Act No. 26 of the Public Acts of 1988, being sections 54.202, 54.203, 54.206, 54.207, 54.208, 54.210, 54.210c, and 54.210d of the Michigan Compiled Laws; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Sections 2, 3, 6, 7, 8, 10, 13, and 14 of Act
- 2 No. 74 of the Public Acts of 1970, sections 2, 6, 8, 13, and 14
- 3 as amended by Act No. 26 of the Public Acts of 1988, being sec-
- 4 tions 54.202, 54.203, 54.206, 54.207, 54.208, 54.210, 54.210c,
- 5 and 54.210d of the Michigan Compiled Laws, are amended to read as
- 6 follows:

- 1 Sec. 2. As used in this act:
- 2 (a) "Property corner" means a geographic point on the 3 surface of the earth, which is on, is a part of, and controls a
- 4 property line.
- 5 (b) "Property controlling corner" for a property means a
- 6 public land survey corner or any property corner which does not
- 7 lie on a property line of the property in question but which con-
- 8 trols the location of 1 or more of the property corners of the
- 9 property in question.
- 10 (c) "Public land survey corner" means any corner actually
- II established and monumented in an original survey or resurvey used
- 12 as a basis of legal description for issuing a patent for the land
- 13 to a private person from the United States government.
- (d) "Corner", unless otherwise qualified, means a property
- 15 corner, a property controlling corner, a public land survey
- 16 corner, or any combination of these.
- (e) "Accessory", WITH RESPECT to a corner, means any
- 18 exclusively identifiable physical object whose spatial relation-
- 19 ship to the corner is recorded. Accessories may be bearing
- 20 trees, bearing objects, monuments, reference monuments, line
- 21 trees, pits, mounds, charcoal-filled bottles, steel or wooden
- 22 stakes, or other objects.
- 23 (f) "Monument" means an accessory that is presumed to
- 24 occupy the exact A MARKER THAT OCCUPIES THE position of a corner
- 25 -which shall be monumented in the field with permanent markers
- 26 which AND THAT POSSESSES OR IS MADE TO possess a magnetic
- 27 field. -, unless previously monumented with iron stakes, and

- 1 capped with some device legibly showing the license number of the
- 2 licensed land surveyor responsible for placing them.
- 3 (g) "Reference monument" means a special monument that does
- 4 not occupy the same geographical position as the corner itself
- 5 but whose spatial relationship to the corner is recorded and
- 6 which serves to witness the corner.
- 7 (h) "Licensed surveyor" "SURVEYOR" means a PROFESSIONAL
- 8 surveyor who is licensed to practice -land PROFESSIONAL survey-
- 9 ing under the occupational code, Act No. 299 of the Public Acts
- 10 of 1980, being sections 339.101 to 339.2721 of the Michigan
- 11 Compiled Laws. , and has a paid up license for that calendar
- 12 year, or who is authorized under that act to practice land
- 13 surveying.
- (i) "Board" means the board of -land PROFESSIONAL survey-
- 15 ors, as established by section 2002 of the occupational code, Act
- 16 No. 299 of the Public Acts of 1980, being section 339.2002 of the
- 17 Michigan Compiled Laws.
- 18 . (J) "CORNER RECORD" MEANS A WRITTEN RECORD ON A FORM,
- 19 APPROVED BY THE BOARD, OF A CORNER ESTABLISHED, REESTABLISHED,
- 20 MONUMENTED, REMONUMENTED, RESTORED, REHABILITATED, PERPETUATED,
- 21 OR USED AS A CONTROL IN A SURVEY.
- 22 (K) "COUNTY SURVEYOR" MEANS AN INDIVIDUAL HOLDING THE ELEC-
- 23 TIVE OFFICE OF COUNTY SURVEYOR OF 1846, CONSISTENT WITH SECTION
- 24 95 OF CHAPTER 14 OF THE REVISED STATUTES, BEING SECTION 54.95 OF
- 25 THE MICHIGAN COMPILED LAWS, OR AN INDIVIDUAL APPOINTED AS COUNTY
- 26 REPRESENTATIVE PURSUANT TO SECTION 9 OF THE STATE SURVEY AND

- 1 REMONUMENTATION ACT, ACT NO. 345 OF THE PUBLIC ACTS OF 1990,
- 2 BEING SECTION 54.269 OF THE MICHIGAN COMPILED LAWS.
- 3 Sec. 3. -A IF A PUBLIC LAND SURVEY CORNER OR AN ACCESSORY
- 4 TO THE CORNER IS USED BY A SURVEYOR AS A CONTROL IN A SURVEY, NOT
- 5 MORE THAN 90 DAYS AFTER COMPLETION OF THE SURVEY, THE surveyor
- 6 shall complete, sign, -stamp with his seal, and file with the
- 7 register of deeds of the county where the corner is situated, a
- 8 written record of corner establishment or restoration to be
- 9 known as a "corner record" for every CORNER RECORD FOR THE
- 10 public land survey corner -and OR accessory to -such THE
- 11 corner, -which is established, reestablished, monumented, remonu-
- 12 mented, restored, rehabilitated, perpetuated or used as control
- 13 in any survey by such surveyor, and within 90 days thereafter,
- 14 unless the corner MONUMENT and its accessories are
- 15 -substantially as described in an existing corner record filed
- 16 in accordance with the provisions of UNDER this act.
- Sec. 6. (!) The register of deeds shall receive FOR
- 18 RECORDING the completed corner record and preserve it in a hard-
- 19 bound book. The books shall be numbered in numerical order as
- 20 filed.
- 21 (2) The register of deeds shall number the -forms- CORNER
- 22 RECORDS in numerical order as they are filed.
- 23 (3) The book and page number in which the corner record is
- 24 filed shall be placed by the register of deeds near that same
- 25 corner on a cross index plat ON AN INDEX which the register of
- 26 deeds shall provide for such a THAT purpose.

- (4) The register of deeds shall make these records available
  2 for public inspection during all usual office hours.
- 3 (5) For purposes of determining the filing fee, the THE
- 4 FEE FOR RECORDING A corner record shall be -considered as a simi-
- 5 lar service to a recording DETERMINED as provided in section
- 6 2567(1)(a) of the revised judicature act of 1961, Act No. 236 of
- 7 the Public Acts of 1961, being section 600.2567 of the Michigan
- 8 Compiled Laws.
- 9 Sec. 7. -In every case where IF a corner record -of a
- 10 public land survey corner is required to be filed under the
- 11 provisions of this act, the surveyor shall -reconstruct or reha-
- 12 bilitate the monument of such corner and accessories to such
- 13 corner, so that it shall be left by him in such MONUMENT THE
- 14 CORNER AND EACH ACCESSORY TO THE CORNER, AND LEAVE THE MONUMENT
- 15 IN SUCH A physical condition that it remains as permanent a monu-
- 16 ment as is reasonably possible. and so that the same may be
- 17 reasonably expected to be located with facility at all times in
- 18 the future. IF ACCESS TO THE CORNER LOCATION WILL CREATE AN
- 19 UNSAFE CONDITION, THE SURVEYOR MAY INSTALL AT LEAST 4 REFERENCE
- 20 MONUMENTS INTERRELATED AND VISIBLE WITH THE CORNER LOCATION AND
- 21 EACH OTHER BY ANGULAR AND LINEAR MEASUREMENTS.
- 22 Sec. 8. A corner record shall not be filed unless it is
- 23 signed, by a licensed surveyor and stamped with the surveyor's
- 24 seal, or DATED, AND SEALED BY THE SURVEYOR. HOWEVER, in the
- 25 case of an agency of the United States government or the THIS
- 26 state, the certificate may be signed by the chief of the survey
- 27 party making the survey and SHALL BE approved, signed, DATED,

- I and sealed by the <del>licensed</del> surveyor in responsible charge of
- 2 the agency AND MAY ALSO BE SIGNED BY THE CHIEF OF THE SURVEY
- 3 PARTY MAKING THE SURVEY.
- 4 Sec. 10. (1) When a monument is set and it is not SET, A
- 5 MONUMENT SHALL POSSESS A MAGNETIC FIELD, BE AT LEAST 1/2 INCH IN
- 6 DIAMETER AND A MINIMUM OF 18 INCHES IN LENGTH, AND BE LEGIBLY
- 7 CAPPED SHOWING THE LICENSE NUMBER OF THE SURVEYOR.
- 8 (2) UNLESS IT IS TO BE SET in a public -highway, the
- 9 ROADWAY, A monument shall be set not more than 6 inches above
- 10 WITH NOT LESS THAN 2/3 OF ITS LENGTH BELOW the surface of the
- 11 surrounding ground. nor more than 6 inches below the surface of
- 12 the ground. When
- (3) IF a corner -occurs IS LOCATED in a public -highway
- 14 which- ROADWAY AND THE ROADWAY is not hard-surfaced AT THE
- 15 CORNER, the monument shall be placed at least 6 inches below the
- 16 surface of THE ROADWAY. such highway. When a highway
- 17 (4) IF A CORNER IS LOCATED IN A PUBLIC ROADWAY AND THE
- 18 ROADWAY is hard-surfaced at the corner, whether by concrete,
- 19 tarvia ASPHALT, or otherwise, a circular opening at least 6
- 20 inches in diameter shall be left at the corner and properly cov-
- 21 ered with a metal cover. The monument shall be placed in the
- 22 opening beneath the cover THE MONUMENT SHALL BE VISIBLE OR CON-
- 23 TAINED WITHIN A VISIBLE PROTECTED ENCLOSURE AND SHALL COMPLY WITH
- 24 ANY REQUIREMENTS OF THE AGENCY HAVING JURISDICTION.
- 25 (5) IF A CORNER TO BE MONUMENTED IS LOCATED ON A ROCK OUT-
- 26 CROPPING, AN IRON BAR AT LEAST 1/2 INCH IN DIAMETER SHALL BE

- 1 DRILLED AND GROUTED INTO SOLID ROCK TO A DEPTH OF AT LEAST 8
- 2 INCHES.
- 3 Sec. 13. Failure to comply with the provisions of this act
- 4 is sufficient grounds for the suspension or revocation of the
- 5 license of a -licensed land surveyor.
- 6 Sec. 14. (1) A person who defaces, destroys, alters, or
- 7 removes a corner MONUMENT OR REFERENCE MONUMENT is guilty of a
- 8 misdemeanor and shall be punished by a fine of not more than
- 9 \$500.00 \$1,000.00, or imprisonment for not more than -60 180
- 10 days, or both, and shall be responsible for the costs of reestab-
- 11 lishment AND replacement OF THE MONUMENT and filing of
- 12 the corner RECORD by a licensed land surveyor. A corner
- 13 MONUMENT OR REFERENCE MONUMENT may be temporarily removed for
- 14 construction purposes if the corner is properly witnessed by a
- 15 -licensed land surveyor -prior to BEFORE removal. The -corner-
- 16 MONUMENT shall be reset, rewitnessed, and refiled by a -licensed
- 17 land surveyor within 30 days after the completion of
- 18 construction. A corner MONUMENT OR REFERENCE MONUMENT shall not
- 19 be temporarily removed for more than I year. A person who knows
- 20 that a corner MONUMENT OR REFERENCE MONUMENT has been defaced,
- 21 destroyed, altered, or removed shall report that fact to the
- 22 county surveyor of the county in which the corner is located.
- 23 (2) As used in this section, "person" means an individual,
- 24 or any public or private legal entity.
- 25 Section 2. Sections 9 and 11 of Act No. 74 of the Public
- 26 Acts of 1970, being sections 54.209 and 54.210a of the Michigan
- 27 Compiled Laws, are repealed.
