

## **HOUSE BILL No. 5655**

March 7, 1996, Introduced by Reps. Gnodtke, Randall, Gernaat, Llewellyn, Jellema, Bobier, Dalman, Bodem, Hill, DeLange, Prusi, Kukuk, DeMars and Hammerstrom and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend sections 43526 and 43527 of Act No. 451 of the Public Acts of 1994, entitled

"Natural resources and environmental protection act," as added by Act No. 57 of the Public Acts of 1995, being sections 324.43526 and 324.43527 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Sections 43526 and 43527 of Act No. 451 of the
- 2 Public Acts of 1994, as added by Act No. 57 of the Public Acts of
- 3 1995, being sections 324.43526 and 324.43527 of the Michigan
- 4 Compiled Laws, are amended to read as follows:
- 5 Sec. 43526. (1) A person shall not hunt deer during the
- 6 firearm deer season without purchasing a firearm deer license.
- 7 The fee for a resident firearm deer license is \$12.50. The fee
- 8 for a nonresident firearm deer license is \$100.00. Where
- 9 authorized by the department, a person may purchase a second

- 1 firearm deer license in 1 season. The fee for a second resident
- 2 firearm deer license is \$12.50. The fee for a second nonresident
- 3 firearm deer license is \$100.00. The department may issue orders
- 4 under part 401 designating the kind of deer that may be taken -
- 5 and may limit the issuance of a second firearm deer license for
- 6 use in areas it considers THE GEOGRAPHIC AREA IN WHICH ANY
- 7 LICENSE ISSUED UNDER THIS SECTION IS VALID, WHEN advisable in
- 8 managing deer.
- 9 (2) The department may issue a kill tag with or as part of
- 10 each deer license. The kill tag shall bear the license number.
- 11 The kill tag shall MAY also include space for other pertinent
- 12 information -including the date and month of killing the animal,
- 13 the sex of the animal, and size of the antlers REQUIRED BY THE
- 14 DEPARTMENT. This pertinent information shall be completed by the
- 15 licensee upon the killing of a deer. The kill tag, if issued, is
- 16 part of the license.
- (3) The department shall charge a nonrefundable application
- 18 fee not to exceed \$3.00 for each person who applies for an ant-
- 19 lerless deer permit.
- Sec. 43527. (1) A person shall not hunt deer with a bow and
- 21 arrow during the bow and arrow deer season without a bow and
- 22 arrow deer license. The fee for a resident bow and arrow deer
- 23 license is \$12.50. The fee for a nonresident bow and arrow deer
- 24 license is \$75.00. The resident bow and arrow deer license fee
- 25 for a minor child is \$6.25. Where authorized by the department,
- 26 a person may purchase a second bow and arrow deer license in 1
- 27 season. The fee for a second resident bow and arrow deer license

- 1 is \$12.50. The fee for a second nonresident bow and arrow deer
- 2 license is \$75.00. The department may issue orders under
- 3 part 401 designating the kind of deer which may be taken and
- 4 -may limit the issuance of a second bow and arrow deer license
- 5 for use in areas it considers THE GEOGRAPHIC AREA IN WHICH ANY
- 6 LICENSE ISSUED UNDER THIS SECTION IS VALID, WHEN advisable in
- 7 managing deer.
- 8 (2) The department may issue a kill tag with, or as a part
- 9 of, each bow and arrow deer license. Section 43526(2) applies
- 10 with respect to a bow and arrow deer license.
