

HOUSE BILL No. 5687

March 14, 1996, Introduced by Reps. Hanley, Kelly, Goschka, Brewer, Martinez, DeMars, Scott, Weeks, Parks, Brater, Cherry and Prusi and referred to the Committee on Regulatory Affairs.

A bill to amend section 2012 of Act No. 299 of the Public Acts of 1980, entitled as amended

"Occupational code,"

as amended by Act No. 103 of the Public Acts of 1992, being section 339.2012 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 2012 of Act No. 299 of the Public Acts
- 2 of 1980, as amended by Act No. 103 of the Public Acts of 1992,
- 3 being section 339.2012 of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- 5 Sec. 2012. The following persons are exempt from the
- 6 requirements of this article:
- 7 (a) A professional engineer employed by a railroad or other
- 8 interstate corporation, whose employment and practice is confined
- 9 to the property of the corporation.

- 1 (b) A designer of a manufactured product, if the
- 2 manufacturer of the product assumes responsibility for the qual-
- 3 ity of the product.
- 4 (c) An owner doing architectural, engineering, or surveying
- 5 work upon or in connection with the construction of a building on
- 6 the owner's property for the owner's own use to which employees
- 7 and the public are not generally to have access.
- 8 (d) A person not licensed under this article who is plan-
- 9 ning, designing, or directing the construction of a residence
- 10 building not exceeding 3,500 square feet in calculated floor
- 11 area. As used in this subdivision and section 2014(e),
- 12 "calculated floor area" means that portion of the total gross
- 13 area, measured to the outside surfaces of exterior walls intended
- 14 to be habitable, including a heater or utility room, but not
- 15 including a crawl space; an unfinished and nonhabitable portion
- 16 of a basement or attic; or a garage, open porch, balcony, ter-
- 17 race, or court.
- (e) A person who is licensed to engage in the practice of
- 19 architecture, professional engineering, or professional surveying
- 20 in another state while temporarily in this state to present a
- 21 proposal for services.
- 22 (F) A PERSON NOT LICENSED UNDER THIS ARTICLE WHO IS PLAN-
- 23 NING, DESIGNING, OR DIRECTING THE CONSTRUCTION OF A BUILDING FOR
- 24 WHICH A WAIVER HAS BEEN GRANTED UNDER SECTION 11 OF THE CONSTRUC-
- 25 TION CODE ACT OF 1972, ACT NO. 230 OF THE PUBLIC ACTS OF 1972,
- 26 BEING SECTION 125.1511 OF THE MICHIGAN COMPILED LAWS.

Section 2. This amendatory act shall not be enacted unless 2 Senate Bill No. or House Bill No. 5686 (bill request 3 no. 05739'95) of the 88th Legislature is enacted into law.
