A bill to amend sections 442 and 447 of Act No. 328 of the Public Acts of 1931, entitled as amended
"The Michigan penal code,"
being sections 750.442 and 750.447 of the Michigan Compiled
Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Sections 442 and 447 of Act No. 328 of the
- 2 Public Acts of 1931, being sections 750.442 and 750.447 of the
- 3 Michigan Compiled Laws, are amended to read as follows:
- Sec. 442. (1) Participating in prize fight-Any A person
- 5 who shall be a party to, or engage PARTICIPATES in a prize
- 6 fight in this state, or who shall aid or abet therein, shall be
- 7 AIDS OR ABETS A PERSON IN HIS OR HER PARTICIPATION IN A PRIZE
- 8 FIGHT IN THIS STATE, IS quilty of a felony.

- 1 (2) AS USED IN THIS CHAPTER, "PRIZE FIGHT" MEANS A CONTEST
- 2 BETWEEN OPPONENTS THAT MEETS BOTH OF THE FOLLOWING:
- 3 (A) CONTESTANTS ARE AWARDED ANY FORM OF COMPENSATION OR
- 4 REMUNERATION FOR THEIR EFFORTS, WHETHER MONETARY OR OTHERWISE.
- 5 (B) CONTESTANTS ATTACK AND DEFEND THEMSELVES WITH FISTS,
- 6 HANDS, FEET, HEAD, ARMS, LEGS, OR ANY OTHER PART OF THE BODY,
- 7 WHETHER OR NOT GLOVES OR PADDING OR ANY EQUIPMENT, TOOL, OR
- 8 WEAPON IS USED.
