A bill to amend section 506 of Act No. 281 of the Public Acts of 1967, entitled

"Income tax act of 1967,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 8 ELIGIBLE VETERAN, WHO SERVED IN ANY WAR, OR SERVED IN THE ARMED
- 9 FORCES OF THE UNITED STATES PURSUANT TO A PRESIDENTIAL EXECUTIVE

 1 ORDER OR PRESIDENTIAL PROCLAMATION. FOR PURPOSES OF THIS CHAPTER
2 AND FOR TAX YEARS BEGINNING AFTER DECEMBER 31, 1995, THE STATE
 3 EQUALIZED VALUE ALLOWANCE FOR AN ELIGIBLE SERVICEPERSON, ELIGIBLE
