

HOUSE BILL No. 6097

September 18, 1996, Introduced by Reps. Law, Hammerstrom, Griffin, Palamara, Porreca, Bodem and McManus and referred to the Committee on Regulatory Affairs.

A bill to amend sections 16131 and 16263 of Act No. 368 of the Public Acts of 1978, entitled as amended "Public health code,"

as amended by Act No. 126 of the Public Acts of 1995, being sections 333.16131 and 333.16263 of the Michigan Compiled Laws; and to add section 16338 and part 179.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 21 (2) Notwithstanding section 16261, a person who was spe-
- 22 cially trained at an institution of higher education in this
- 23 state to assist a physician in the field of orthopedics and upon
- 24 completion of training, received a 2-year associate of science
- 25 degree as an orthopedic physician's assistant before January 1,
- 26 1977, may use the title "orthopedic physician's assistant"

- 3 AS FOLLOWS:
- 4 (A) APPLICATION PROCESSING FEE.....\$ 20.00
- 5 (B) LICENSE FEE, PER YEAR..... 75.00
- 7 PART 179. RESPIRATORY CARE
- 8 SEC. 17901. (1) AS USED IN THIS PART:
- 9 (A) "HEALTH FACILITY" MEANS A HEALTH FACILITY OR AGENCY
- 10 LICENSED UNDER ARTICLE 17.
- 11 (B) "MEDICAL DIRECTOR" MEANS A PHYSICIAN WHO IS RESPONSIBLE
- 12 FOR THE QUALITY, SAFETY, APPROPRIATENESS, AND EFFECTIVENESS OF
- 13 THE RESPIRATORY CARE PROVIDED, WHO ASSISTS IN QUALITY MONITORING,
- 14 PROTOCOL DEVELOPMENT, AND COMPETENCY VALIDATION, AND WHO MEETS
- 15 ALL OF THE FOLLOWING:
- 16 (i) IS THE MEDICAL DIRECTOR OF AN INPATIENT OR OUTPATIENT

- 20 (ii) HAS SPECIAL INTEREST AND KNOWLEDGE IN THE DIAGNOSIS AND
- 21 TREATMENT OF CARDIOPULMONARY DISORDERS AND DISEASES.
- 22 (iii) IS QUALIFIED BY TRAINING OR EXPERIENCE, OR BOTH, IN
- 23 THE MANAGEMENT OF ACUTE AND CHRONIC CARDIOPULMONARY DISORDERS AND
- 24 DISEASES.
- 25 (C) "PHYSICIAN" MEANS THAT TERM AS DEFINED IN SECTIONS 17001
- 26 AND 17501.

- 1 (D) "PRACTICE OF RESPIRATORY CARE" INCLUDES, BUT IS NOT
- 2 LIMITED TO, ALL OF THE FOLLOWING PERFORMED IN A HEALTH FACILITY
- 3 OR OTHER LOCATION CONSIDERED APPROPRIATE OR NECESSARY BY THE PRE-
- 4 SCRIBING PHYSICIAN:
- 5 (i) THE ADMINISTRATION OF PHARMACOLOGIC AGENTS, DIAGNOSTIC
- 6 AGENTS, AND THERAPEUTIC AGENTS RELATED TO RESPIRATORY CARE PROCE-
- 7 DURES AS NECESSARY TO IMPLEMENT PREVENTIVE, DIAGNOSTIC, THERAPEU-
- 8 TIC. AND REHABILITATIVE REGIMENS PRESCRIBED BY A PHYSICIAN.
- 9 (ii) THE TRANSCRIPTION AND IMPLEMENTATION OF WRITTEN, ORAL,
- 10 AND TELECOMMUNICATED ORDERS OF A PHYSICIAN PERTAINING TO RESPIRA-
- 11 TORY CARE PROCEDURES.
- 12 (iii) THE OBSERVATION, MONITORING, AND ASSESSMENT OF SIGNS
- 13 AND SYMPTOMS, REACTIONS, BEHAVIORS, AND PHYSICAL RESPONSES TO
- 14 RESPIRATORY CARE TREATMENT AND DIAGNOSTIC TESTING. INCLUDING THE
- 15 DETERMINATION OF WHETHER THE SIGNS AND SYMPTOMS, REACTIONS,
- 16 BEHAVIORS, AND PHYSICAL RESPONSES EXHIBIT ABNORMAL
- 17 CHARACTERISTICS.
- 18 (iv) THE DEVELOPMENT, IMPLEMENTATION, AND MODIFICATION OF
- 19 RESPIRATORY CARE TREATMENT PLANS BASED ON OBSERVED ABNORMALITIES,
- 20 REFERRALS, RESPIRATORY CARE PROTOCOLS, CLINICAL PATHWAYS, AND
- 21 CHANGES IN TREATMENT PLAN PURSUANT TO THE WRITTEN, ORAL, AND TEL-
- 22 ECOMMUNICATED ORDERS OF A PHYSICIAN.
- 23 (v) THE APPLICATION, OPERATION, AND MANAGEMENT OF MECHANICAL
- 24 VENTILATORY SUPPORT AND OTHER MEANS OF LIFE SUPPORT.
- 25 (vi) THE INITIATION OF EMERGENCY PROCEDURES UNDER RULES
- 26 PROMULGATED BY THE BOARD OR AS OTHERWISE PERMITTED UNDER THIS
- 27 PART.

- 1 (vii) THE COLLECTION OF BLOOD SPECIMENS FOR, AND THE
- 2 PERFORMANCE OF, CARDIOPULMONARY DIAGNOSTIC TESTING PROCEDURES
- 3 INCLUDING, BUT NOT LIMITED TO, BLOOD GAS ANALYSIS.
- 4 (E) "RESPIRATORY THERAPIST" MEANS AN INDIVIDUAL LICENSED
- 5 UNDER THIS ARTICLE TO ENGAGE IN THE PRACTICE OF RESPIRATORY
- 6 CARE.
- 7 (2) IN ADDITION TO THE DEFINITIONS IN THIS PART, ARTICLE 1
- 8 CONTAINS GENERAL DEFINITIONS AND PRINCIPLES OF CONSTRUCTION
- 9 APPLICABLE TO ALL ARTICLES IN THIS CODE AND PART 161 CONTAINS
- 10 DEFINITIONS APPLICABLE TO THIS PART.
- 11 SEC. 17903. (1) AFTER THE EFFECTIVE DATE OF THE RULES
- 12 PROMULGATED BY THE BOARD UNDER THIS ARTICLE, SUBJECT TO SUBSEC-
- 13 TION (2), AN INDIVIDUAL SHALL NOT ENGAGE IN THE PRACTICE OF RES-
- 14 PIRATORY CARE UNLESS LICENSED OR OTHERWISE AUTHORIZED UNDER THIS
- 15 ARTICLE.
- 16 (2) THIS PART DOES NOT PROHIBIT ANOTHER LICENSEE UNDER THIS
- 17 ARTICLE FROM ENGAGING IN ACTIVITIES THAT FALL UNDER THE DEFINI-
- 18 TION OF THE PRACTICE OF RESPIRATORY CARE IF THE ACTIVITIES ARE
- 19 AUTHORIZED UNDER THE LICENSE HELD BY THE LICENSEE.

- 21 ATED IN THE DEPARTMENT AND SHALL CONSIST OF THE FOLLOWING 7 MEM-
- 22 BERS WHO MEET THE REQUIREMENTS OF PART 161:
- 23 (A) FOUR INDIVIDUALS WHO MEET THE REQUIREMENTS OF
- 24 SECTION 16135
- 25 (B) ONE MEDICAL DIRECTOR.
- 26 (C) TWO PUBLIC MEMBERS.

- 1 SEC. 17907. (1) IN PROMULGATING RULES TO ESTABLISH
- 2 REQUIREMENTS FOR LICENSURE UNDER SECTION 16145, THE BOARD SHALL
- 3 ADOPT ALL OF THE FOLLOWING REQUIREMENTS:
- 4 (A) SUCCESSFUL COMPLETION OF AN ACCREDITED RESPIRATORY THER-
- 5 APIST TRAINING PROGRAM APPROVED BY THE BOARD.
- 6 (B) HAVING AT LEAST A 2-YEAR ASSOCIATE'S DEGREE FROM AN
- 7 ACCREDITED COLLEGE OR UNIVERSITY APPROVED BY THE BOARD.
- 8 (C) HAVING THE CREDENTIAL CONFERRED BY THE NATIONAL BOARD
- 9 FOR RESPIRATORY CARE OR ITS SUCCESSOR ORGANIZATION AS A
- 10 REGISTERED RESPIRATORY THERAPIST OR ITS SUCCESSOR CREDENTIAL, AS
- 11 APPROVED BY THE BOARD.
- 12 (2) SUBJECT TO SECTION 16204, THE BOARD SHALL BY RULE PRE-
- 13 SCRIBE CONTINUING EDUCATION REQUIREMENTS AS A CONDITION FOR
- 14 LICENSE RENEWAL.
