



# SENATE BILL No. 1104

September 10, 1996, Introduced by Senators YOUNG, CONROY, V. SMITH, CHERRY, STALLINGS, A. SMITH, HART, O'BRIEN, DE BEAUSSAERT, KOIVISTO, BYRUM, VAUGHN, DINGELL, BERRYMAN, MILLER and PETERS and referred to the Committee on Families, Mental Health and Human Services.

A bill to amend Act No. 280 of the Public Acts of 1939, entitled as amended "The social welfare act," as amended, being sections 400.1 to 400.119b of the Michigan Compiled Laws, by adding section 57i.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Act No. 280 of the Public Acts of 1939, as  
2 amended, being sections 400.1 to 400.119b of the Michigan  
3 Compiled Laws, is amended by adding section 57i to read as  
4 follows:

5 SEC. 57I. (1) THE FAMILY INDEPENDENCE AGENCY SHALL NOT SEEK  
6 A FEDERAL WAIVER UNDER A FEDERALLY FUNDED ASSISTANCE PROGRAM  
7 UNLESS THE WAIVER IS MANDATED OR AUTHORIZED BY STATE STATUTE.

8 (2) NOT LESS THAN 60 DAYS BEFORE SUBMITTING A WAIVER REQUEST  
9 TO THE FEDERAL GOVERNMENT, THE FAMILY INDEPENDENCE AGENCY SHALL

1 PROVIDE A COPY OF THE WAIVER REQUEST TO THE SENATE AND HOUSE  
2 STANDING COMMITTEES AND APPROPRIATIONS SUBCOMMITTEES THAT DEAL  
3 WITH HUMAN SERVICES.

4 (3) IF THE AID TO FAMILIES WITH DEPENDENT CHILDREN, MEDI-  
5 CAID, OR FOOD STAMPS PROGRAMS ARE REPLACED BY FEDERAL BLOCK  
6 GRANTS, THIS SECTION APPLIES TO ANY REQUEST BY THE FAMILY INDE-  
7 PENDENCE AGENCY FOR FEDERAL APPROVAL TO VARY FROM A FEDERAL  
8 REQUIREMENT UNDER THE BLOCK GRANT PROGRAM.

9 (4) THIS SECTION APPLIES TO REQUESTS FOR FEDERAL WAIVERS .OR  
10 FOR FEDERAL APPROVAL MADE AFTER THE EFFECTIVE DATE OF THIS  
11 SECTION.
