THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLE

An act to provide for the establishment in portions of counities lying outside the limits of incorporated cities and villages
of zoning districts within which the proper use of land and natural resources may be encouraged or regulated by ordinance, and
for which districts provisions may also be adopted designating
the location of, the size of, the uses that may be made of, the
minimum open spaces, sanitary, safety, and protective measures
that are required for, and the maximum number of families that
may be housed in dwellings, buildings, and structures that are

- 2 licensed residential facilities; to provide for a method for the
- 3 adoption of ordinances and amendments to ordinances; to provide
