

SUBSTITUTE FOR
SENATE BILL NO. 537

A bill to amend 1931 PA 328, entitled
"The Michigan penal code,"
by amending section 473 (MCL 750.473), as added by 1993 PA 140.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 473. (1) Except as otherwise provided in
2 subsection (4), a person shall not use a tobacco product on
3 school property.

4 (2) A person who violates subsection (1) is guilty of a mis-
5 demeanor, punishable by a fine of not more than \$50.00. IF A
6 MINOR VIOLATES SUBSECTION (1), THE DISTRICT COURT HAS CONCURRENT
7 JURISDICTION OVER THE CASE.

8 (3) As used in this section:

9 (a) "School district" means a school district, local act
10 school district, or intermediate school district, as those terms
11 are defined in the REVISED school code, ~~of 1976, Act No. 451 of~~

8 ture and other real estate owned, leased, or otherwise controlled
9 by a school district.

10 (c) "Tobacco product" means a preparation of tobacco to be
11 inhaled, chewed, or placed in a person's mouth.

12 (d) "Use a tobacco product" means ~~any~~ 1 OR MORE of the
13 following:

14 (i) The carrying by a person of a lighted cigar, cigarette,
15 pipe, or other lighted smoking device.

16 (ii) The inhaling or chewing of a tobacco product.

17 (iii) The placing of a tobacco product within a person's
18 mouth.

19 (4) Subsection (1) does not apply to that part of school
20 property consisting of outdoor areas including, but not limited
21 to, an open-air stadium, during either of the following time
22 periods:

23 (a) Saturdays, Sundays, and other days on which there are no
24 regularly scheduled school hours.

25 (b) After 6 p.m. on days during which there are regularly
26 scheduled school hours.
