## **HOUSE BILL No. 4010**

January 8, 1997, Introduced by Rep. Fitzgerald and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 243e (MCL 750.243e).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 243e. (1) Any EXCEPT AS PROVIDED IN SUBSECTION (2),
- 2 A person , firm, copartnership or corporation, who violates
- 3 any of the provisions of sections 243a to 243d SECTION 243A,
- 4 243B, 243C, OR 243D, or who violates the terms of any A permit
- 5 issued thereunder UNDER SECTION 243A, 243B, 243C, OR 243D, is
- 6 guilty of a misdemeanor PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- 7 THAN 93 DAYS OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 8 (2) A PERSON WHO OFFERS FOR SALE, EXPOSES FOR SALE, SELLS AT
- 9 RETAIL, OR KEEPS WITH INTENT TO SELL AT RETAIL FIREWORKS IN
- 10 VIOLATION OF SECTION 243A IS GUILTY OF A CRIME AS FOLLOWS:

- 19 FIREWORKS, THE PERSON IS GUILTY OF A MISDEMEANOR PUNISHABLE BY
- 20 IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR A FINE OF NOT MORE THAN
- 21 \$1,000.00, OR BOTH.
- 22 (E) IF THE VIOLATION INVOLVES 5 OR MORE POUNDS OF FIREWORKS
- 23 BUT LESS THAN 25 POUNDS OF FIREWORKS AND THE PERSON HAS 1 OR MORE
- 24 PRIOR CONVICTIONS FOR VIOLATING SECTION 243A, 243B, 243C, OR 243D
- 25 OR A PERMIT ISSUED UNDER SECTION 243A, 243B, 243C, OR 243D, THE
- 26 PERSON IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT
- 27 MORE THAN 4 YEARS OR A FINE OF NOT MORE THAN \$2,500.00, OR BOTH.

- 1 (F) IF THE VIOLATION INVOLVES 25 OR MORE POUNDS OF
- 2 FIREWORKS, THE PERSON IS GUILTY OF A FELONY PUNISHABLE BY IMPRIS-
- 3 ONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF NOT MORE THAN
- 4 \$2,500.00, OR BOTH.
- 5 (3) AS USED IN THIS SECTION, "PERSON" MEANS AN INDIVIDUAL,
- 6 PARTNERSHIP, CORPORATION, ASSOCIATION, GOVERNMENTAL ENTITY, OR
- 7 OTHER LEGAL ENTITY.
