## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 626A. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
- 2 ACT TO THE CONTRARY, IF, AFTER THE DEADLINE FOR FILING NOMINATING
- 3 PETITIONS UNDER SECTION 624, THE NUMBER OF CANDIDATES FOR PRE-
- 4 CINCT DELEGATE IN EACH PRECINCT IS EQUAL TO OR LESS THAN THE
- 5 NUMBER OF PERSONS TO BE ELECTED AT THE AUGUST PRIMARY, THEN THE
- 6 COUNTY CLERK SHALL CERTIFY THAT THERE IS NO CONTEST IN THE ELEC-
- 7 TION FOR PRECINCT DELEGATE. THE COUNTY CLERK SHALL DELIVER THE
- 8 CERTIFICATION OF NO CONTEST TO THE BOARD OF ELECTION
- 9 COMMISSIONERS. UPON RECEIPT OF THE CERTIFICATION FROM THE COUNTY
- 10 CLERK UNDER THIS SECTION, THE BOARD OF ELECTION COMMISSIONERS
- 11 SHALL NOT HAVE ANY CANDIDATE NAMES PRINTED ON THE BALLOT FOR
