- 4 PROVIDE COVERAGE FOR A MINIMUM OF 48 HOURS OF IN-PATIENT HOSPITAL
- 5 SERVICES FOLLOWING A VAGINAL DELIVERY AND A MINIMUM OF 96 HOURS
- 6 OF IN-PATIENT HOSPITAL SERVICES FOLLOWING A CESAREAN SECTION FOR
- 7 A MOTHER AND HER NEWLY BORN CHILD.
- 8 (2) SUBSECTION (1) DOES NOT APPLY TO A HEALTH MAINTENANCE
- 9 ORGANIZATION CONTRACT THAT PROVIDES HEALTH CARE SERVICES FOR
