- 2 (a) "Confidential information" means an individual's name,
- 3 address, social security number, telephone number, account number
- 4 at a financial institution, credit record, or investment record.
- 5 (b) "Person" means an individual, partnership, corporation,

- 8 in this state for either of the following:

- 10 (ii) The providing of credit to an individual.

- 1 Sec. 3. (1) Except as provided in subsection (2), a person

- 26 THAT MICHIGAN LAW PROHIBITS _____ FROM REFUSING TO
