## **HOUSE BILL No. 6259**

November 5, 1998, Introduced by Rep. Varga and referred to the Committee on Regulatory Affairs.

A bill to amend 1851 PA 156, entitled

"An act to define the powers and duties of the county boards of commissioners of the several counties, and to confer upon them certain local, administrative and legislative powers; and to prescribe penalties for the violation of the provisions of this act,"

by amending section 10b (MCL 46.10b), as amended by 1998 PA 97.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 10b. (1) Except for an ordinance described in subsec-
- 2 tion (2) or (3), the violation of an ordinance adopted pursuant
- 3 to section 11(j) shall be punishable by a fine of not more than
- 4 \$500.00 or imprisonment for not more than 90 days, or both.
