## SENATE BILL NO. 972

March 3, 1998, Introduced by Senators BULLARD, BENNETT and JAYE and referred to the Committee on Hunting, Fishing and Forestry.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license; to provide for the forfeiture of firearms possessed in violation of this act; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; and to repeal all acts and parts of acts inconsistent with the provisions of this act,"

by amending section 2 (MCL 28.422), as amended by 1994 PA 338.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. (1) Except as provided in subsection (2), a person
- 2 shall not purchase, carry, or transport a pistol in this state
- 3 without first having obtained a license for the pistol as pre-
- 4 scribed in this section.
- 5 (2) A person who brings a pistol into this state who is on
- 6 leave from active duty with the armed forces of the United States
- 7 or who has been discharged from active duty with the armed forces

- 1 of the United States shall obtain a license for the pistol within
- 2 30 days after his or her arrival in this state.
- 3 (3) The commissioner or chief of police of a city, township,
- 4 or village police department that issues licenses to purchase,
- 5 carry, or transport pistols, or his or her duly authorized
- 6 deputy, or the sheriff or his or her duly authorized deputy, in
- 7 the parts of a county not included within a city, township, or
- 8 village having an organized police department, in discharging the
- 9 duty to issue licenses shall with due speed and diligence issue
- 10 licenses to purchase, carry, or transport pistols to qualified
- 11 applicants residing within the city, village, township, or
- 12 county, as applicable unless he or she has probable cause to
- 13 believe that the applicant would be a threat to himself or her-
- 14 self or to other individuals, or would commit an offense with the
- 15 pistol that would violate a law of this or another state or of
- 16 the United States. An applicant is qualified if all of the fol-
- 17 lowing circumstances exist:
- 18 (a) The person is not subject to an order or disposition for

- (b) The person is 18 years of age or older or, if the seller
- 23 is licensed pursuant to section 923 of title 18 of the United
- 24 States Code, 18 U.S.C. 923, is 21 years of age or older.
- (c) The person is a citizen of the United States and is a
- 26 legal resident of this state.

- 1 (d) A felony charge against the person is not pending at the
- 2 time of application.
- 3 (e) The person is not prohibited from possessing, using,
- 4 transporting, selling, purchasing, carrying, shipping, receiving,
- 5 or distributing a firearm under section 224f of the Michigan
- 6 penal code, Act No. 328 of the Public Acts of 1931, being sec-
- 7 tion 750.224f of the Michigan Compiled Laws 1931 PA 328, MCL
- 8 750.224F.
- **9** (f) The person has not been adjudged insane in this state or
- 10 elsewhere unless he or she has been adjudged restored to sanity
- 11 by court order.
- 12 (g) The person is not under an order of involuntary commit-
- 13 ment in an inpatient or outpatient setting due to mental
- 14 illness.
- 15 (h) The person has not been adjudged legally incapacitated
- 16 in this state or elsewhere. This subdivision does not apply to a
- 17 person who has had his or her legal capacity restored by order of
- 18 the court.
- 19 (i) The person correctly answers 70% or more of the ques-
- 20 tions on a basic pistol safety review questionnaire approved by
- 21 the basic pistol safety review board and provided to the individ-
- 22 ual free of charge by the licensing authority. If the person
- 23 fails to correctly answer 70% or more of the questions on the
- 24 basic pistol safety review questionnaire, the licensing authority
- 25 shall inform the person of the questions he or she answered
- 26 incorrectly and allow the person to attempt to complete another
- 27 basic pistol safety review questionnaire. The person shall not

- 1 be allowed to attempt to complete more than 2 basic pistol safety
- 2 review questionnaires on any single day. The licensing authority
- 3 shall allow the person to attempt to complete the questionnaire
- 4 during normal business hours on the day the person applies for
- 5 his or her license.
- 6 (4) Applications for licenses under this section shall be
- 7 signed by the applicant under oath upon forms provided by the
- 8 director of the department of state police. Licenses to pur-
- 9 chase, carry, or transport pistols shall be executed in tripli-
- 10 cate upon forms provided by the director of the department of
- 11 state police and shall be signed by the licensing authority.
- 12 Three copies of the license shall be delivered to the applicant
- 13 by the licensing authority.
- 14 (5) Upon the sale of the pistol, the seller shall fill out
- 15 the license forms describing the pistol sold, together with the
- 16 date of sale, and sign his or her name in ink indicating that the
- 17 pistol was sold to the licensee. The licensee shall also sign
- 18 his or her name in ink indicating the purchase of the pistol from
- 19 the seller. The seller may retain a copy of the license as a
- 20 record of the sale of the pistol. The licensee shall return
- 21 2 copies of the license to the licensing authority within 10 days
- 22 following the purchase of the pistol.
- (6) One copy of the license shall be retained by the licens-
- 24 ing authority as an official record for a period of 6 years. The
- 25 other copy of the license shall be forwarded by the licensing
- 26 authority within 48 hours to the director of the department of

- 2 the date of its issue.
- **3** (7) This section does not apply to the purchase of pistols
- 4 from wholesalers by dealers regularly engaged in the business of
- 5 selling pistols at retail, or to the sale, barter, or exchange of
- 6 pistols kept solely as relics, curios, or antiques not made for
- 7 modern ammunition or permanently deactivated. This section does
- 8 not prevent the transfer of ownership of pistols that are inher-
- 9 ited if the license to purchase is approved by the commissioner
- 10 or chief of police, sheriff, or their authorized deputies, and
- 11 signed by the personal representative of the estate or by the
- 12 next of kin having authority to dispose of the pistol.
- 13 (8) The licensing authority shall provide a basic pistol
- 14 safety brochure to each applicant for a license under this sec-
- 15 tion before the applicant answers the basic pistol safety review
- 16 questionnaire. A basic pistol safety brochure shall contain, but
- 17 is not limited to providing, information on all of the following
- 18 subjects:
- 19 (a) Rules for safe handling and use of pistols.
- 20 (b) Safe storage of pistols.
- 21 (c) Nomenclature and description of various types of
- 22 pistols.
- 23 (d) The responsibilities of owning a pistol.
- 24 (9) The basic pistol safety brochure shall be supplied in
- 25 addition to the safety pamphlet required by section 9b.
- 26 (10) The basic pistol safety brochure required in subsection
- 27 (8) shall be produced by a national nonprofit membership

- 1 organization that provides voluntary pistol safety programs that
- 2 include training individuals in the safe handling and use of
- 3 pistols.
- 4 (11) A person who forges any matter on an application for a
- 5 license under this section is guilty of a felony, punishable by
- 6 imprisonment for not more than 4 years or a fine of not more than
- 7 \$2,000.00, or both.
- 8 (12) A licensing authority shall implement this section
- 9 during all of the licensing authority's normal business hours and
- 10 shall set hours for implementation that allow an applicant to use
- 11 the license within the time period set forth in subsection (6).
- 12 (13) AN APPLICATION FOR A LICENSE UNDER THIS SECTION, AND A
- 13 LICENSING AUTHORITY'S DATA RELATING TO THE STATUS OF THAT APPLI-
- 14 CATION, SHALL BE MADE AVAILABLE TO THE PUBLIC IN COMPLIANCE WITH
- 15 THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL 15.231 TO
