- 1 SEC. 506B. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
- 2 ACT, THE COURT MAY ORDER AN INDIVIDUAL CONVICTED OF COMMITTING A
- 3 VIOLATION OF THIS ACT IN WHICH AN INDIVIDUAL WHO IS A VULNERABLE
- 4 ADULT OR IS LESS THAN 18 YEARS OF AGE IS A VICTIM OF THAT VIOLA-
- 5 TION TO PAY NOT MORE THAN TWICE THE FINE OTHERWISE AUTHORIZED FOR
- 6 THAT VIOLATION OR TO PAY THE FINE AUTHORIZED UNDER SUBSECTION 7 (2).
- 8 (2) IF THE VIOLATION IS NOT OTHERWISE PUNISHABLE BY A FINE,
- 9 THE COURT, IN ADDITION TO ANY AUTHORIZED PENALTY, MAY ORDER THE
- 10 INDIVIDUAL TO PAY A FINE AS FOLLOWS:
