- 15 (G) EXISTENCE OF OSTEOPOROSIS SUPPORT GROUPS.

- 17 (I) NUMBER AND LOCATION OF BONE DENSITY TESTING EQUIPMENT.

- SEC. 9457. (1) THERE IS APPROPRIATED FROM THE GENERAL FUND

- 26 (2) THE DEPARTMENT MAY ACCEPT FROM THE STATE AND FEDERAL

- 7 SEC. 9459. (1) THE OSTEOPOROSIS EDUCATION FUND IS CREATED
- 8 IN THE STATE TREASURY. THE DEPARTMENT SHALL EXPEND THE FUND ONLY
- 9 TO CARRY OUT ITS DUTIES UNDER THIS PART.
- 10 (2) THE STATE TREASURER SHALL DEPOSIT IN THE FUND ALL MONEY
- 11 RECEIVED BY THE DEPARTMENT UNDER SECTION 9457 AND ALL MONEY
- 12 RECEIVED BY THE FUND AS OTHERWISE PROVIDED BY LAW.
- 13 (3) THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 14 FUND. INTEREST AND EARNINGS OF THE FUND SHALL BE CREDITED TO THE
- 15 FUND. MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL
- 16 REMAIN IN THE FUND AND SHALL NOT REVERT TO THE GENERAL FUND.
