 25 FESSIONAL TEACHING STANDARDS, AND IF THE INDIVIDUAL MEETS THE  
 26 REQUIREMENTS FOR A PROFESSIONAL TEACHING CERTIFICATE, THE STATE  
 27 BOARD SHALL ISSUE THE INDIVIDUAL A PROFESSIONAL TEACHING

**1** CERTIFICATE WITHOUT CHARGING A FEE UNDER SUBSECTION (1) FOR THE  
**2** PROFESSIONAL TEACHING CERTIFICATE.
