- (c) A complete physical description of the individual.
- 24 (2) A registration may contain the following:
- (a) The individual's blood type and whether a DNA identifi-
- 26 cation profile of the individual is available.

- 1 (b) A recent photograph of the individual.
- 2 (3) The form used for registration under this act shall
- 3 contain a written statement that explains the duty of the indi-
- 4 vidual being registered to provide notice of a change of address
- 5 under section 5 and the procedures for providing that notice.
- **6** (4) The individual may sign the registration or notice.
- 7 (5) The officer, court, or an employee of the agency regis-
- 8 tering the individual or receiving or accepting a registration
- 9 under section 4 shall sign the registration form.
- 10 (6) An individual shall not knowingly provide false or mis-
- 11 leading information concerning a registration or notice.
- 12 (7) The department shall prescribe the form for a notifica-
- 13 tion required under section 5 and the format for forwarding the
- 14 notification to the department.
