A bill to amend 1976 PA 451, entitled "The revised school code," (MCL 380.1 to 380.1852) by adding section 1531d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1531D. (1) THE PROFESSIONAL CERTIFICATE LOAN PROGRAM
- 2 IS CREATED, TO BE ADMINISTERED BY THE DEPARTMENT. THE DEPARTMENT
- 3 SHALL DO ALL OF THE FOLLOWING:
- 4 (A) MAKE LOW INTEREST LOANS PURSUANT TO THIS SECTION TO
- 5 INDIVIDUALS HOLDING PROVISIONAL TEACHING CERTIFICATES, TO BE USED
- 6 BY THE INDIVIDUALS SOLELY FOR TUITION, AND RELATED FEES APPROVED
- 7 BY THE DEPARTMENT, FOR CLASSES REQUIRED TO COMPLETE THE
- 8 18-SEMESTER-HOUR EDUCATION REQUIREMENT FOR ISSUANCE OF A PROFES-
- 9 SIONAL TEACHING CERTIFICATE PURSUANT TO R 390.1132(1) OF THE

- 19 (A) HOLDS A PROVISIONAL TEACHING CERTIFICATE.

- 1 (3) THE DEPARTMENT SHALL PAY THE AMOUNT OF A LOAN MADE UNDER

- 3 LOAN RECIPIENT IS ENROLLED, TO BE APPLIED TO THE LOAN RECIPIENT'S

- 5 (4) THERE IS CREATED THE PROFESSIONAL CERTIFICATE LOAN PRO-
- 6 GRAM FUND AS A SEPARATE FUND IN THE STATE TREASURY, TO BE ADMIN-
- 7 ISTERED BY THE DEPARTMENT. THE DEPARTMENT MAY ACCEPT MONEY FOR
- 8 THE PROFESSIONAL CERTIFICATE LOAN PROGRAM FUND FROM ANY SOURCE.
- 9 THE STATE TREASURER SHALL DEPOSIT THAT MONEY AND AMOUNTS REPAID
- 10 ON LOANS MADE UNDER THIS SECTION, AND SHALL CREDIT THE AMOUNTS TO
- 11 THE PROFESSIONAL CERTIFICATE LOAN PROGRAM FUND. THE DEPARTMENT
- 12 SHALL USE THE PROFESSIONAL CERTIFICATE LOAN PROGRAM FUND ONLY TO
- 13 PROVIDE MONEY FOR LOANS MADE UNDER THIS SECTION.
- 14 (5) THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 15 PROFESSIONAL CERTIFICATE LOAN PROGRAM FUND MONEY AND SHALL CREDIT
- 16 EARNINGS TO THE PROFESSIONAL CERTIFICATE LOAN PROGRAM FUND.
- 17 (6) MONEY IN THE PROFESSIONAL CERTIFICATE LOAN PROGRAM FUND
- 18 AT THE END OF A FISCAL YEAR SHALL NOT REVERT TO THE GENERAL FUND
