



# HOUSE BILL No. 4870

September 28, 1999, Introduced by Reps. Schermesser, Wojno, O'Neill, Spade, Basham, DeHart, Julian, Hale, Daniels, Scott, Bovin and Bogardus and referred to the Committee on Criminal Law and Corrections.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16g of chapter XVII (MCL 777.16g), as amended by 1999 PA 39.
