

## **HOUSE BILL No. 4892**

September 28, 1999, Introduced by Rep. Bisbee and referred to the Committee on Insurance and Financial Services.

A bill to amend 1956 PA 218, entitled

"The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding sections 1203a and 1203b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1203A. A LICENSE IS NOT REQUIRED UNDER THIS CHAPTER IF
- 2 A PERSON ACTS AS AN EMPLOYEE OF A CREDITOR OR VENDOR AND RECEIVES
- 3 NO COMMISSION FOR SECURING AND FORWARDING INFORMATION FOR THE
- 4 PURPOSE OF OBTAINING GROUP CREDIT LIFE INSURANCE, GROUP CREDIT
- 5 ACCIDENT AND HEALTH INSURANCE, GROUP CREDIT PROPERTY INSURANCE,
- 6 OR GROUP INVOLUNTARY UNEMPLOYMENT INSURANCE OR FOR ENROLLING
- 7 INDIVIDUALS IN OR ISSUING CERTIFICATES OF INSURANCE FOR GROUP
- 8 CREDIT LIFE INSURANCE, GROUP CREDIT ACCIDENT AND HEALTH INSUR-
- 9 ANCE, OR GROUP INVOLUNTARY UNEMPLOYMENT INSURANCE.

- 1 SEC. 1203B. (1) THE COMMISSIONER SHALL ISSUE A LIMITED
- 2 AGENT'S LICENSE TO AN APPLICANT OTHERWISE QUALIFIED UNDER THIS
- 3 CHAPTER WHOSE INSURANCE ACTIVITIES ARE LIMITED TO THE SOLICITA-
- 4 TION AND SALE OF ANY OF THE FOLLOWING:
- 5 (A) CREDIT LIFE INSURANCE.
- 6 (B) CREDIT ACCIDENT AND HEALTH INSURANCE.
- 7 (C) CREDIT PROPERTY INSURANCE.
- 8 (D) CREDIT INVOLUNTARY UNEMPLOYMENT INSURANCE.
- **9** (E) FAMILY LEAVE INSURANCE.
- 10 (2) THE PROGRAM OF STUDY, EXAMINATION, AND CONTINUING EDUCA-
- 11 TION REQUIREMENTS OF THIS CHAPTER DO NOT APPLY TO A LIMITED
- 12 LICENSE ISSUED UNDER THIS SECTION.
