

HOUSE BILL No. 5127

November 10, 1999, Introduced by Rep. DeHart and referred to the Committee on Constitutional Law and Ethics.

A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2721) by adding article 17A.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 ARTICLE 17A

- 2 SEC. 1757. (1) A PERSON LICENSED TO OPERATE AN ADULT ENTER-
- 3 TAINMENT ESTABLISHMENT UNDER THIS ARTICLE SHALL DISPLAY THE
- 4 LICENSE IN A CONSPICUOUS MANNER ON THE PREMISES FOR WHICH THE
- 5 LICENSE IS ISSUED.
- 6 (2) A MASSAGIST LICENSED UNDER THIS ARTICLE SHALL HAVE THE
- 7 LICENSE IN HIS OR HER POSSESSION DURING THE COURSE OF PERFORMANCE
- 8 OF SERVICES AS A MASSAGIST OR WHILE ON THE PREMISES OF A MASSAGE
- 9 ESTABLISHMENT AND SHALL DISPLAY THE LICENSE UPON REQUEST OF A
- 10 PEACE OFFICER OR A REPRESENTATIVE OF THE DEPARTMENT.

- 1 (3) IN ADDITION TO ANY PENALTIES ASSESSED UNDER ARTICLE 6, A
- 2 VIOLATION OF THIS SECTION IS A MISDEMEANOR PUNISHABLE BY A FINE
- 3 OF NOT MORE THAN \$1,000.00.
- 4 SEC. 1758. THE DEPARTMENT SHALL NOT ISSUE A LICENSE TO
- 5 ENGAGE IN THE OCCUPATION OF MASSAGIST UNDER THIS ARTICLE UNLESS
- 6 THE APPLICANT EXECUTES AND FILES WITH THE DEPARTMENT A SWORN
- 7 APPLICATION THAT INCLUDES ALL OF THE FOLLOWING:
- 8 (A) THE APPLICANT'S FULL NAME, INCLUDING NICKNAMES OR
- 9 ALIASES, RESIDENTIAL ADDRESS, PLACE OF EMPLOYMENT INCLUDING

- 11 BIRTH, AND DRIVER LICENSE NUMBER.
- 12 (B) A PHOTOGRAPH OF THE APPLICANT TAKEN WITHIN 30 DAYS OF
- 13 APPLICATION.
- 14 (C) THE APPLICANT'S CERTIFICATION OR SWORN STATEMENT THAT
- 15 THE APPLICANT HAS NEVER BEEN CONVICTED OF A CRIME OR VIOLATION OF
- 16 A LOCAL ORDINANCE INVOLVING LEWDNESS, PROSTITUTION, PROMOTING
- 17 PROSTITUTION, SEXUAL ASSAULT OR ASSAULT WITH INTENT TO COMMIT
- 18 CRIMINAL SEXUAL CONDUCT, SEXUAL MISCONDUCT, INDECENT EXPOSURE,
- 19 INCEST, RAPE OR CRIMINAL SEXUAL CONDUCT, OR SODOMY, OR HAS NOT
- 20 REGISTERED AS A SEX OFFENDER, IN THIS STATE OR ANY OTHER STATE OR
- 21 JURISDICTION WITHIN THE 3 YEARS PRIOR TO THE DATE OF
- 22 APPLICATION.
- 23 (D) A LETTER OR CERTIFICATION OF A PHYSICIAN STATING THAT
- 24 THE APPLICANT HAS BEEN EXAMINED AND FOUND FREE OF COMMUNICABLE
- 25 DISEASES AS OF A DATE NOT MORE THAN 30 DAYS PRIOR TO SUBMISSION
- 26 OF THE APPLICATION.

- 1 (E) A COPY OF THE APPLICANT'S FINGERPRINTS ON A FORM
- 2 FURNISHED BY THE DEPARTMENT OF STATE POLICE.
- 3 (F) OTHER INFORMATION, FORMS, OR DOCUMENTS REQUIRED BY THE
- 4 DEPARTMENT.
- 5 SEC. 1759. (1) THE DEPARTMENT SHALL NOT ISSUE A LICENSE FOR
- 6 THE OPERATION OF AN ADULT ENTERTAINMENT ESTABLISHMENT UNLESS THE
- 7 APPLICANT HAS EXECUTED AND FILED WITH THE DEPARTMENT A CERTIFIED
- 8 OR SWORN APPLICATION IN COMPLIANCE WITH THIS ARTICLE.
- 9 (2) AN APPLICATION FOR LICENSE FOR THE OPERATION OF AN ADULT
- 10 ENTERTAINMENT ESTABLISHMENT SHALL STATE THE FULL NAME OF THE
- 11 APPLICANT APPEARING PURSUANT TO SECTION 1760, INCLUDING NICKNAMES
- 12 OR ALIASES, RESIDENTIAL ADDRESS, PLACE OF EMPLOYMENT INCLUDING
- 13 ADDRESS AND TELEPHONE NUMBER, SOCIAL SECURITY NUMBER, DATE OF
- 14 BIRTH, DRIVER LICENSE NUMBER, A PHOTOGRAPH OF THE APPLICANT TAKEN
- 15 WITHIN 30 DAYS OF THE APPLICATION, FEDERAL EMPLOYER'S IDENTIFICA-
- 16 TION NUMBER, AND AN ADDRESS OF THE PREMISES FOR WHICH THE APPLI-
- 17 CATION FOR LICENSE IS MADE. THE APPLICATION SHALL PROVIDE THE
- 18 FULL NAME, INCLUDING NICKNAMES AND ALIASES, RESIDENTIAL ADDRESS,
- 19 PLACE OF EMPLOYMENT INCLUDING ADDRESS AND TELEPHONE NUMBER, DATE
- 20 OF BIRTH, SOCIAL SECURITY NUMBER, AND A RECENT PHOTOGRAPH TAKEN
- 21 WITHIN 30 DAYS OF THE APPLICATION OF EACH PERSON EMPLOYED BY THE
- 22 ADULT ENTERTAINMENT ESTABLISHMENT. THE APPLICATION SHALL SPECIF-
- 23 ICALLY IDENTIFY WHO IS TO BE RESPONSIBLE FOR THE DAY-TO-DAY MAN-
- 24 AGEMENT OF THE ADULT ENTERTAINMENT ESTABLISHMENT.
- 25 (3) IF THE APPLICANT IS A CORPORATION, THE APPLICATION SHALL
- 26 INCLUDE ALL OF THE FOLLOWING:

- 1 (A) A COPY OF THE ARTICLES OR CERTIFICATE OF INCORPORATION
- 2 CERTIFIED BY THE DEPARTMENT FOR A DOMESTIC CORPORATION OR THE
- 3 APPROPRIATE OFFICIAL OF THE STATE OF INCORPORATION FOR A CORPORA-
- 4 TION FORMED IN ANOTHER STATE.
- 5 (B) IF THE APPLICANT IS A CORPORATION FORMED IN ANOTHER
- 6 STATE, A CERTIFICATE OF AUTHORITY TO TRANSACT BUSINESS FROM THE
- 7 DEPARTMENT.
- 8 (C) A CERTIFICATE CONTAINING THE FULL NAME, INCLUDING NICK-
- 9 NAMES OR ALIASES, PLACE OF EMPLOYMENT INCLUDING ADDRESS AND TELE-
- 10 PHONE NUMBER, SOCIAL SECURITY NUMBER, DATE OF BIRTH, DRIVER
- 11 LICENSE NUMBER, AND A PHOTOGRAPH TAKEN WITHIN 30 DAYS OF APPLICA-
- 12 TION OF EACH DIRECTOR, OFFICER, AND PRINCIPAL OWNER OF THE
- 13 APPLICANT. EACH DIRECTOR, OFFICER, AND PRINCIPAL OWNER OF THE
- 14 APPLICANT MUST SIGN THE CERTIFICATE, AND EACH SIGNATURE MUST BE
- 15 AN ORIGINAL SIGNATURE SEPARATELY WITNESSED AND ACKNOWLEDGED BY A
- 16 NOTARY PUBLIC.
- 17 (D) THE NAMES AND ADDRESSES OF ALL HOLDERS OF STOCK OF THE
- 18 APPLICANT AS OF A DATE WITHIN 30 DAYS BEFORE THE DATE OF APPLICA-
- 19 TION, CERTIFIED AS TRUE AND CORRECT BY AN AUTHORIZED DIRECTOR OR
- 20 OFFICER OF THE CORPORATION.
- 21 (4) IF THE APPLICANT IS A LIMITED LIABILITY COMPANY, THE
- 22 APPLICATION SHALL INCLUDE ALL OF THE FOLLOWING:
- 23 (A) A COPY OF THE ARTICLES OF ORGANIZATION CERTIFIED BY THE
- 24 DEPARTMENT FOR A DOMESTIC CORPORATION OR THE APPROPRIATE OFFICIAL
- 25 OF THE STATE OF FORMATION FOR A LIMITED LIABILITY COMPANY FORMED
- 26 IN ANOTHER STATE.

- 1 (B) IF THE APPLICANT IS A LIMITED LIABILITY COMPANY FORMED
- 2 IN ANOTHER STATE, A CERTIFICATE OF AUTHORITY TO TRANSACT BUSINESS
- 3 FROM THE DEPARTMENT.
- 4 (C) A CERTIFICATE CONTAINING THE FULL NAME, INCLUDING NICK-
- 5 NAMES OR ALIASES, PLACE OF EMPLOYMENT INCLUDING ADDRESS AND TELE-
- 6 PHONE NUMBER, SOCIAL SECURITY NUMBER, DATE OF BIRTH, DRIVER
- 7 LICENSE NUMBER, AND A PHOTOGRAPH TAKEN WITHIN 30 DAYS OF APPLICA-
- 8 TION OF EACH MANAGER AND PRINCIPAL OWNER OF THE APPLICANT. EACH
- 9 MANAGER AND PRINCIPAL OWNER OF THE APPLICANT MUST SIGN THE CER-
- 10 TIFICATE, AND EACH SIGNATURE MUST BE AN ORIGINAL SIGNATURE SEPA-
- 11 RATELY WITNESSED AND ACKNOWLEDGED BY A NOTARY PUBLIC.
- 12 (D) THE NAMES AND ADDRESSES OF ALL HOLDERS OF MEMBERSHIP
- 13 INTERESTS IN THE APPLICANT AS OF A DATE WITHIN 30 DAYS PRIOR TO
- 14 THE DATE OF APPLICATION, CERTIFIED AS TRUE AND CORRECT BY A MAN-
- 15 AGER OR MEMBER OF THE APPLICANT.
- 16 (5) IF THE APPLICANT IS A PARTNERSHIP OR OTHER UNINCORPOR-
- 17 ATED ASSOCIATION, THE APPLICATION SHALL INCLUDE A CERTIFICATE
- 18 CONTAINING THE FULL NAME, INCLUDING NICKNAMES OR ALIASES, PLACE
- 19 OF EMPLOYMENT INCLUDING ADDRESS AND TELEPHONE NUMBER, SOCIAL
- 20 SECURITY NUMBER, DATE OF BIRTH, DRIVER LICENSE NUMBER, AND A PHO-
- 21 TOGRAPH TAKEN WITHIN 30 DAYS OF APPLICATION OF EVERY PARTNER OR
- 22 MEMBER. EACH PARTNER OR MEMBER OF THE APPLICANT MUST SIGN THE
- 23 CERTIFICATE AND EACH SIGNATURE MUST BE AN ORIGINAL SIGNATURE SEP-
- 24 ARATELY WITNESSED AND ACKNOWLEDGED BY A NOTARY PUBLIC.
- 25 (6) THE DEPARTMENT SHALL NOT ACCEPT AN APPLICATION OR ISSUE
- 26 A LICENSE TO OPERATE AN ADULT ENTERTAINMENT ESTABLISHMENT AT A
- 27 LOCATION IF THE DEPARTMENT HAS DENIED AN APPLICATION TO OPERATE

1 AN ADULT ENTERTAINMENT ESTABLISHMENT AT THAT LOCATION WITHIN THE 2 PRIOR 6 MONTHS. Enacting section 1.
