EXECUTIVE BUDGET BILL

A bill to make appropriations for the department of environmental quality for the fiscal year ending September 30, 2001; to provide for the expenditure of those appropriations; to create funds and accounts; to require reports; to prescribe certain powers and duties of certain state agencies and officials; to authorize certain transfers by certain state agencies; and to provide for the disposition of fees and other income received by the various state agencies.

8	Sec. 201. (1) Pursuant to section 30 of article IX of the state
9	constitution of 1963, total state spending under part 1 for fiscal
10	year 2000-2001 is \$257,838,600.00 and state appropriations to be paid
11	to local units of government are as follows:

21	(2) If it appears to the principal executive officer of a
22	department or branch that state spending to local units of government
23	will be less than the amount that was projected to be expended for any
24	quarter under subsection (1), the principal executive officer shall
25	immediately give notice of the approximate shortfall to the state
26	budget director, the senate and house of representatives standing
27	committees on appropriations, and the senate and house fiscal
28	agencies.
29	Sec. 202. The expenditures and funding sources authorized under

- 1 this bill are subject to the management and budget act, 1984 PA 431,
- 2 MCL 18.1101 to 18.154.
- 3 Sec. 203. As used in this bill:
- 4 (a) "CESARS" means chemical evaluation search and retrieval
- 5 system.
- 6 (b) "Department" means the Michigan department of environmental
- 7 quality.
- 8 (c) "FEMA" means the federal emergency management agency.
- 9 (d) "FTE" means full-time equated.
- 10 (e) "GIS" means geographic information system.
- 11 (f) "IDG" means interdepartmental grant.
- 12 (g) "IDT" means intradepartmental transfer.
- 13 (h) "MDCH" means the Michigan department of community health.
- 14 (i) "MDOT" means the Michigan department of transportation.
- 15 (j) "MDSP" means the Michigan department of state police.
- 16 Sec. 204. (1) Beginning October 1, a hiring freeze is imposed on
- 17 the state classified civil service. State departments and
- 18 agencies are prohibited from hiring any new full-time state classified
- 19 civil service employees and prohibited from filling any vacant state
- 20 classified civil service positions. This hiring freeze does not apply
- 21 to internal transfers of classified employees from one position to
- 22 another within a department or to positions that are funded with 80%
- 23 or more federal or restricted funds.
- 24 (2) The state budget director shall grant exceptions to this
- 25 hiring freeze when the state budget director believes that the hiring
- 26 freeze will result in rendering a state department or agency unable to
- 27 deliver basic services. The state budget director shall report by the
- $28 30^{TH}$ of each month to the chairpersons of the senate and house of
- 29 representatives standing committees on appropriations the number of
- 30 exceptions to the hiring freeze approved during the previous month and

- 2 Sec. 205. The department of civil service shall bill the
- 3 department at the end of the first fiscal quarter for the 1% charge
- 4 authorized by section 5 of article XI of the state constitution of
- 5 1963. Payments shall be made for the total amount of the billing
- 6 by the end of the second fiscal quarter.
- 7 Sec. 206. (1) In addition to the funds appropriated in part 1
- 8 there is appropriated an amount not to exceed \$30,000,000.00 for
- 9 federal contingency funds. These funds are not available for
- 10 expenditure until they have been transferred to another line item in
- 11 this bill pursuant to section 393(2) of the management and budget
- 12 act,1984 PA 431, MCL 18.1393.
- 13 (2) In addition to the funds appropriated in part 1, there is
- 14 appropriated an amount not to exceed \$5,000,000.00 for state
- 15 restricted contingency funds. These funds are not available for
- 16 expenditure until they have been transferred to another line item in
- 17 this bill pursuant to section 393(2) of the management and budget act,

- 19 (3) In addition to the funds appropriated in part 1, there is
- 20 appropriated an amount not to exceed \$100,000.00 for local contingency
- 21 funds. These funds are not available for expenditure until they
- 22 have been transferred to another line item in this bill pursuant to
- 23 section 393(2) of the management and budget act, 1984 PA 431, MCL
- 24 18.1393.
- 25 (4) In addition to the funds appropriated in part 1, there is
- 26 appropriated an amount not to exceed \$100,000.00 for private
- 27 contingency funds. These funds are not available for expenditure
- 28 until they have been transferred to another line item in this bill
- 29 pursuant to section 393(2) of the management and budget act, 1984 PA
- 30 431, MCL 18.1393.

- 1 Sec. 207. The department shall provide the state budget director,
- 2 the subcommittees on natural resources and environmental quality of
- 3 the house and senate appropriations committees, and the senate and
- 4 house fiscal agencies with an annual report on restricted fund
- 5 balances, projected revenues, and expenditures.
- 6 Sec. 208. (1) In addition to the funds appropriated for the
- 7 environmental cleanup and redevelopment program listed in part 1, the
- 8 department of environmental quality is authorized to expend amounts
- 9 remaining from prior fiscal year appropriations to meet
- 10 funding needs of legislatively approved sites.
- 11 (2) Unexpended and unencumbered amounts remaining from
- 12 appropriations from the environmental protection bond fund contained
- 13 in 1989 PA 180, 1990 PA 55, 1990 PA 194, 1991 PA 31, 1991 PA 160, 1993
- 14 PA 74, 1993 PA 353, 1994 PA 442, 1996 PA 353, and 1997 PA 114 are

- 21 for any site listed in this bill and any site listed in the public
- 22 acts referenced in this section.
- 23 Sec. 209. The department shall continue to pilot the use of the
- 24 Internet to fulfill the reporting requirements in this bill. This may
- 25 include transmission of reports via electronic mail to the recipients
- 26 identified for each reporting requirement or it may include placement
- 27 of reports on the Internet or on the Intranet. The appropriations
- 28 subcommittee shall be notified in writing of the Internet/Intranet
- 29 site of any such report.
- 30 Sec. 210. Sixty days before beginning any effort to privatize,

- 1 the department shall submit a complete project plan to the appropriate
- 2 subcommittees of the senate and house of representatives standing
- 3 committees on appropriations and the senate and house fiscal agencies.
- 4 The plan shall include the criteria under which the privatization
- 5 initiative will be evaluated. The evaluation shall be completed and
- 6 submitted to the appropriate subcommittees of the senate and house of
- 7 representatives standing committees on appropriations and the senate
- 8 and house fiscal agencies within 30 months.
- 9 Sec. 211. (1) The department shall report all of the following
- 10 information relative to allocations made in part 1 for the
- 11 environmental cleanup and redevelopment program, state cleanup,
- 12 emergency actions, superfund cleanup, the leaking underground storage
- 13 tank cleanup program, and the environmental protection bond projects
- 14 under section 19508(7) of the natural resources and environmental
- protection act 1994 PA 451, MCL 324.19508, to the state budget
- 16 director, the senate and house of representatives appropriations
- 17 subcommittees on environmental quality, and the senate and house
- 18 fiscal agencies:
- 19 (a) The name and location of the site for which an allocation is
- 20 made.
- 21 (b) The nature of the problem encountered at the site.
- 22 (c) A brief description of how the problem will be resolved if the
- 23 allocation is made for a response activity.
- 24 (d) The estimated date that site closure activities will be
- 25 completed.
- 26 (e) The amount of the allocation, or the anticipated financing for
- 27 the site.
- 28 (f) A summary of the sites and the total amount of funds expended
- 29 at the sites at the conclusion of the fiscal year.
- 30 (g) The number of sites that would qualify as brownfields that

- 1 were redeveloped.
- 2 (2) The report prepared shall also include the status of all state
- 3 owned facilities that are on the list compiled under part 201 of the
- 4 natural resources and environmental protection act, 1994 PA 451, MCL
- 5 324.20101 TO 324.20142.
- 6 (3) The report shall include the total amount of funds expended
- 7 during the fiscal year and the total amount of funds awaiting
- 8 expenditure.
- 9 (4) The department shall report the total amount of bond issued
- 10 for the environmental protection bond program issued pursuant to 1994
- 11 PA 451, MCL 324.19301 to 324.19306 and the clean Michigan initiative
- 12 bonds issued pursuant to 1998 PA 294, MCL 324.95101 TO 324.95108.
- 13 (5) The report shall be made available by March 31 of each year.

14 AIR QUALITY

- 15 Sec. 301. From the funds appropriated in part 1, the department
- 16 shall report on the status of implementation planning and permit
- 17 backlog reduction activities under part 55 of the natural resources
- 18 and environmental protection act, 1994 PA 451, MCL 324.5501
- 19 to 324.5542, including status of revenue collections, on an annual
- 20 basis. The report shall be provided to the state budget director, the
- 21 house of representatives and senate appropriations subcommittees on
- 22 environmental quality, and the standing committees of the house of
- 23 representatives and the senate that are responsible for issues
- 24 pertaining to air quality, on or before March 1, 2001.

25 SURFACE WATER QUALITY

- 26 Sec. 401. Of the funds appropriated in part 1 for surface water
- 27 programs, a minimum of \$250,000.00 shall be designated for grants to
- 28 local organizations for water quality monitoring activities.

29 **ENVIRONMENTAL RESPONSE**

30 Sec. 501. The unexpended portion of the appropriation in part 1

- 1 for the state cleanup program; environmental cleanup and redevelopment
- 2 program; emergency cleanup action; contaminated site investigations,
- 3 cleanup and revitalization; revitalization revolving loan program; and
- 4 superfund cleanup projects is considered work project appropriations

- 23 1994 PA 451, MCL 324.21501 to 324.21551, are considered work project
- 24 appropriations and any unencumbered funds are carried forward into the

- 10 fund pursuant to the appropriation in part 1 are to be repaid on

- 13 protection act, 1994 PA 451, MCL 324.5301 to 324.5316.
