

HOUSE BILL No. 5381

February 16, 2000, Introduced by Reps. Allen, Tabor, Mead and Pumford and referred to the Committee on Conservation and Outdoor Recreation.

- 14 (e) "Security interest" means any interest in real or per-
- 15 sonal property that secures payment or performance of an
- 16 obligation.
- 17 (f) "Substituted proceeds of a crime" means any property
- 18 obtained or any gain realized by the sale or exchange of proceeds
- 19 of a crime.
