A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16i of chapter XVII (MCL 777.16i), as added
by 1998 PA 317.

CHAPTER XVII

Sec. 16i. This chapter applies to the following felonies
