A bill to amend 1976 PA 451, entitled
"The revised school code,"

(MCL 380.1 to 380.1852) by adding sections 15a and 602a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 15A. (1) AS PART OF ITS POWERS UNDER SECTION 11A, THE
- 2 SCHOOL BOARD OF A GENERAL POWERS SCHOOL DISTRICT MAY RECEIVE,
- 3 OWN, AND ENJOY A GIFT OF REAL OR PERSONAL PROPERTY MADE BY GRANT,
- 4 DEVISE, BEQUEST, OR IN ANY OTHER MANNER, THAT IS MADE FOR SCHOOL
- 5 PURPOSES UNDER THIS ACT. A SCHOOL BOARD MAY TRANSFER A GIFT OF
- 6 INTANGIBLE PERSONAL PROPERTY OR THE PROCEEDS FROM THAT GIFT TO A
- 7 COMMUNITY FOUNDATION OR EDUCATIONAL FOUNDATION. IF A GIFT

- 17 (B) THE COMMUNITY FOUNDATION OR EDUCATIONAL FOUNDATION IS

- 19 (C) THE COMMUNITY FOUNDATION OR EDUCATIONAL FOUNDATION SUB-
- 20 STANTIALLY VIOLATES ANY CONDITION, LIMITATION, OR REQUIREMENT ON
- 21 THE GIFT.
- 22 (3) UNLESS WAIVED BY THE SCHOOL BOARD TRANSFERRING THE GIFT,
- 23 BEFORE A SCHOOL BOARD MAY TRANSFER A GIFT TO A COMMUNITY FOUNDA-
- 24 TION OR EDUCATIONAL FOUNDATION PURSUANT TO THIS SECTION, THE COM-
- 25 MUNITY FOUNDATION OR EDUCATIONAL FOUNDATION SHALL ESTABLISH A
- 26 DONOR ADVISORY BOARD FOR THAT GIFT. THE DONOR ADVISORY BOARD
- 27 SHALL INCLUDE AT LEAST 1 REPRESENTATIVE OF THE SCHOOL BOARD

- 1 TRANSFERRING THE GIFT. THE DONOR ADVISORY BOARD SHALL DO ALL OF
- 2 THE FOLLOWING:
- 3 (A) MONITOR THE COMMUNITY FOUNDATION'S OR EDUCATIONAL
- 4 FOUNDATION'S COMPLIANCE WITH ANY CONDITION, LIMITATION, OR
- 5 REQUIREMENT ON THE USE OF THE GIFT.
- 6 (B) MAKE RECOMMENDATIONS TO THE COMMUNITY FOUNDATION OR EDU-
- 7 CATIONAL FOUNDATION FOR THE USE OF DISTRIBUTIONS OR OTHER PRO-
- 8 CEEDS FROM THE GIFT.
- 9 (4) A TRANSFER OF A GIFT MADE IN ACCORDANCE WITH THIS SEC-
- 10 TION THAT OCCURRED BEFORE THE EFFECTIVE DATE OF THIS SECTION IS
- 11 RATIFIED AND CONFIRMED AND THE TRANSFER IS CONSIDERED VALID AS IF
- 12 IT HAD BEEN MADE UNDER THIS SECTION.
- 13 (5) AS USED IN THIS SECTION:
- 14 (A) "COMMUNITY FOUNDATION" MEANS THAT TERM AS DEFINED IN
- **15** SECTION 261 OF THE INCOME TAX ACT OF 1967, 1967 PA 281,
- **16** MCL 206.261.
- 17 (B) "CONDITION, LIMITATION, OR REQUIREMENT" DOES NOT INCLUDE
- 18 A MATERIAL RESTRICTION OR CONDITION THAT VIOLATES 26 C.F.R.
- 19 1.170A-9 OR THAT RESTRICTS A COMMUNITY FOUNDATION'S OR EDUCA-
- 20 TIONAL FOUNDATION'S INHERENT POWER OF MODIFICATION DESCRIBED IN

- 22 (C) "EDUCATIONAL FOUNDATION" MEANS A FOUNDATION ORGANIZED
- 23 AND OPERATED TO ASSIST THE FUNCTIONS OF A SCHOOL DISTRICT, INTER-
- 24 MEDIATE SCHOOL DISTRICT, COMMUNITY COLLEGE, OR STATE PUBLIC
- 25 UNIVERSITY.
- 26 (D) "GIFT" DOES NOT INCLUDE STATE SCHOOL AID OR ANOTHER
- 27 GRANT FROM STATE OR FEDERAL SOURCES.

- 1 SEC. 602A. (1) AS PART OF ITS POWERS UNDER SECTION 601A,
- 2 THE INTERMEDIATE SCHOOL BOARD OF AN INTERMEDIATE SCHOOL DISTRICT
- 3 MAY RECEIVE, OWN, AND ENJOY A GIFT OF REAL OR PERSONAL PROPERTY
- 4 MADE BY GRANT, DEVISE, BEQUEST, OR IN ANY OTHER MANNER, THAT IS
- 5 MADE FOR INTERMEDIATE SCHOOL DISTRICT PURPOSES UNDER THIS ACT.
- 6 AN INTERMEDIATE SCHOOL BOARD MAY TRANSFER A GIFT OF INTANGIBLE
- 7 PERSONAL PROPERTY OR THE PROCEEDS FROM THAT GIFT TO A COMMUNITY
- 8 FOUNDATION OR EDUCATIONAL FOUNDATION. IF A GIFT RECEIVED BY THE
- 9 INTERMEDIATE SCHOOL BOARD WAS SUBJECT TO A CONDITION, LIMITATION,
- 10 OR REQUIREMENT, THE TRANSFER MUST BE TO A FUND WITHIN THE COMMU-
- 11 NITY FOUNDATION OR EDUCATIONAL FOUNDATION THAT INCORPORATES A
- 12 CONDITION, LIMITATION, OR REQUIREMENT THAT IS IDENTICAL OR SUB-
- 13 STANTIALLY SIMILAR TO THE CONDITION, LIMITATION, OR REQUIREMENT
- 14 THE GIFT WAS SUBJECT TO. IF A GIFT RECEIVED BY THE INTERMEDIATE
- 15 SCHOOL BOARD WAS NOT SUBJECT TO ANY CONDITION, LIMITATION, OR
- 16 REQUIREMENT, THE TRANSFER MUST BE TO A FUND WITHIN THE COMMUNITY
- 17 FOUNDATION OR EDUCATIONAL FOUNDATION THAT IMPOSES CONDITIONS,
- 18 LIMITATIONS, OR REQUIREMENTS ON THE USE OF THE GIFT PROPERTY FOR
- 19 1 OR MORE INTERMEDIATE SCHOOL DISTRICT PURPOSES UNDER THIS ACT.
- 20 (2) IF AN INTERMEDIATE SCHOOL BOARD TRANSFERS A GIFT TO A
- 21 COMMUNITY FOUNDATION OR EDUCATIONAL FOUNDATION PURSUANT TO THIS
- 22 SECTION AND IF 1 OR MORE OF THE FOLLOWING OCCUR, THE COMMUNITY
- 23 FOUNDATION OR EDUCATIONAL FOUNDATION SHALL RETURN THE GIFT TO THE

- 1 CERTIFICATION AS A COMMUNITY FOUNDATION UNDER SECTION 261 OF THE

- 3 (B) THE COMMUNITY FOUNDATION OR EDUCATIONAL FOUNDATION IS
- 4 LIQUIDATED.
- 5 (C) THE COMMUNITY FOUNDATION OR EDUCATIONAL FOUNDATION SUB-
- 6 STANTIALLY VIOLATES ANY CONDITION, LIMITATION, OR REQUIREMENT ON
- 7 THE GIFT.
- 8 (3) UNLESS WAIVED BY THE INTERMEDIATE SCHOOL BOARD TRANSFER-
- 9 RING THE GIFT, BEFORE AN INTERMEDIATE SCHOOL BOARD MAY TRANSFER A
- 10 GIFT TO A COMMUNITY FOUNDATION OR EDUCATIONAL FOUNDATION PURSUANT
- 11 TO THIS SECTION, THE COMMUNITY FOUNDATION OR EDUCATIONAL FOUNDA-
- 12 TION SHALL ESTABLISH A DONOR ADVISORY BOARD FOR THAT GIFT. THE
- 13 DONOR ADVISORY BOARD SHALL INCLUDE AT LEAST 1 REPRESENTATIVE OF
- 14 THE INTERMEDIATE SCHOOL BOARD TRANSFERRING THE GIFT. THE DONOR
- 15 ADVISORY BOARD SHALL DO ALL OF THE FOLLOWING:
- 16 (A) MONITOR THE COMMUNITY FOUNDATION'S OR EDUCATIONAL
- 17 FOUNDATION'S COMPLIANCE WITH ANY CONDITION, LIMITATION, OR
- 18 REQUIREMENT ON THE USE OF THE GIFT.
- 19 (B) MAKE RECOMMENDATIONS TO THE COMMUNITY FOUNDATION OR EDU-
- 20 CATIONAL FOUNDATION FOR THE USE OF DISTRIBUTIONS OR OTHER PRO-
- 21 CEEDS FROM THE GIFT.
- 22 (4) A TRANSFER OF A GIFT MADE IN ACCORDANCE WITH THIS SEC-
- 23 TION THAT OCCURRED BEFORE THE EFFECTIVE DATE OF THIS SECTION IS
- 24 RATIFIED AND CONFIRMED AND THE TRANSFER IS CONSIDERED VALID AS IF
- 25 IT HAD BEEN MADE UNDER THIS SECTION.
- 26 (5) AS USED IN THIS SECTION:

- 1 (A) "COMMUNITY FOUNDATION" MEANS THAT TERM AS DEFINED IN
- 2 SECTION 261 OF THE INCOME TAX ACT OF 1967, 1967 PA 281,
- 3 MCI 206.261.
- (B) "CONDITION, LIMITATION, OR REQUIREMENT" DOES NOT INCLUDE
- 5 A MATERIAL RESTRICTION OR CONDITION THAT VIOLATES 26
- 6 C.F.R. 1.170A-9 OR THAT RESTRICTS A COMMUNITY FOUNDATION'S OR
- 7 EDUCATIONAL FOUNDATION'S INHERENT POWER OF MODIFICATION DESCRIBED
- 8 IN 26 C.F.R. 1.170A-9.
- (C) "EDUCATIONAL FOUNDATION" MEANS A FOUNDATION ORGANIZED
- 10 AND OPERATED TO ASSIST THE FUNCTIONS OF A SCHOOL DISTRICT, INTER-
- 11 MEDIATE SCHOOL DISTRICT, COMMUNITY COLLEGE, OR STATE PUBLIC
- 12 UNIVERSITY.
- 13 (D) "GIFT" DOES NOT INCLUDE STATE SCHOOL AID OR ANOTHER
- 14 GRANT FROM STATE OR FEDERAL SOURCES.
- Enacting section 1. This amendatory act shall be known and
- 16 may be cited as the "Sam Dubow scholarship law".
