- 1 SEC. 46A. (1) THE AUTHORITY SHALL ESTABLISH AND IMPLEMENT A
- 2 PROGRAM TO PROVIDE ZERO-INTEREST LOANS TO QUALIFIED LAW ENFORCE-
- 3 MENT OFFICERS FOR THE PURCHASE OF A HOME IN A HIGH CRIME AREA.
- 4 (2) AS USED IN THIS SECTION:
- 5 (A) "HIGH CRIME AREA" MEANS AN AREA WITHIN A MUNICIPALITY
- 6 THAT THE DEPARTMENT OF STATE POLICE DETERMINES IS A HIGH CRIME
- 7 AREA BASED ON THE STATE POLICE UNIFORM CRIME REPORTING PROGRAM
- 8 STATISTICS AND OTHER RELEVANT FACTORS AFTER CONSULTATION WITH THE

9 MUNICIPALITY.
