- 5 PREGNANCY-RELATED COVERAGE SHALL PROVIDE COVERAGE FOR THE DIAGNO-
- 6 SIS AND TREATMENT OF INFERTILITY, INCLUDING, BUT NOT LIMITED TO,
- 7 IN VITRO FERTILIZATION, EMBRYO TRANSFER, ARTIFICIAL INSEMINATION,
- 8 GAMETE INTRAFALLOPIAN TUBE TRANSFER, ZYGOTE INTRAFALLOPIAN TUBE
- 9 TRANSFER, AND INTRACYTOPLASMIC SPERM INJECTION.

- 1 INTRAFALLOPIAN TUBE TRANSFER IS REQUIRED ONLY IF ALL OF THE

- 19 THE PROCEDURES REQUIRED TO BE COVERED UNDER THIS SECTION TO VIO-
- 20 LATE ITS RELIGIOUS AND MORAL TEACHINGS AND BELIEFS.
- 21 (4) AS USED IN THIS SECTION, "INFERTILITY" MEANS THE INABIL-
- 22 ITY TO CONCEIVE AFTER 1 YEAR OF UNPROTECTED SEXUAL INTERCOURSE OR
- 23 THE INABILITY TO SUSTAIN A SUCCESSFUL PREGNANCY.
