# SUBSTITUTE FOR HOUSE BILL NO. 4003

A bill to regulate the installation, alteration, maintenance, improvement, and inspection of plumbing; to provide certain powers and duties for certain state agencies and departments; to create a plumbing board; to define plumbing, plumbing contractors, and the classification of plumbers and to set standards for those classifications; to provide for the licensing and regulation of classes of plumbers and plumbing contractors; to prescribe fees and the disposition of money derived from those fees; to provide for the promulgation of rules; to prescribe remedies and penalties; and to repeal acts and parts of acts.

#### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "state plumbing act".
- 3 Sec. 3. As used in this act:

- 1 (a) "Apprentice plumber" means an individual registered
- 2 under this act as an apprentice.
- 3 (b) "Board" means the state plumbing board created in sec-
- 4 tion 13.
- 5 (c) "Building sewer" means that part of the drainage system
- 6 which extends from the end of the building drain and conveys its
- 7 discharge to a public sewer, private sewer, individual sewage
- 8 disposal system, or other point of disposal.
- **9** (d) "Censure" means an expression of disapproval of a
- 10 licensee's or registrant's professional conduct, which conduct is
- 11 not necessarily a violation of this act or a rule promulgated or
- 12 an order issued under this act.
- 13 (e) "Code" means the state construction code provided for in
- 14 section 4 of the Stille-DeRossett-Hale single state construction
- 15 code act, MCL 125.1504, or a part of the code that is of limited
- 16 application and includes a modification of or amendment to the
- **17** code.
- Sec. 5. As used in this act:
- 19 (a) "Department" means the department of consumer and indus-
- 20 try services.
- 21 (b) "Director" means the director of the department of con-
- 22 sumer and industry services or an authorized representative of
- 23 the director.
- 24 (c) "Domestic water treatment and filtering equipment" means
- 25 residential water treatment and filtering equipment used in
- 26 1-family and 2-family dwellings.

- 1 (d) "Enforcing agency" means an enforcing agency as defined
- 2 in section 2a of the Stille-DeRossett-Hale single state
- 3 construction code act, MCL 125.1502a.
- 4 (e) "Governmental subdivision" means a governmental subdivi-
- 5 sion as defined in section 2a of the Stille-DeRossett-Hale single
- 6 state construction code act, MCL 125.1502a.
- **7** Sec. 7. As used in this act:
- 8 (a) "Journey plumber" means an individual, other than a
- 9 plumbing contractor or master plumber, who is qualified to engage
- 10 in the practical installation of plumbing and who is licensed as
- 11 a journey plumber.
- 12 (b) "License" means the document issued to a person under
- 13 this act enabling that person to use a designated title and prac-
- 14 tice an occupation, which practice would otherwise be prohibited
- 15 by this act.
- 16 (c) "Licensee" means a person who has been issued a license
- 17 under this act.
- 18 (d) "Master plumber" means an individual possessing the nec-
- 19 essary skills and qualifications to plan and supervise the
- 20 installation of plumbing and who is licensed as a master
- 21 plumber.
- 22 (e) "Minor repair" means a repair which involves only the
- 23 clearance of stoppages, repair, or replacement of a faucet,
- 24 valve, reinstallation of that same plumbing fixture provided that
- 25 no modifications are made to the plumbing system, or residential
- 26 domestic water treatment and filtering equipment. Minor repair
- 27 does not include any of the following:

- 1 (i) The installation, replacement, or repair of a water
- 2 heater.
- 3 (ii) The repair or replacement of a backflow preventer and
- 4 air admittance valves.
- 5 (iii) A repair or replacement that is only a part of a
- 6 larger or major renovation or repair.
- 7 Sec. 9. As used in this act:
- 8 (a) "Person" means an individual, sole proprietor, partner-
- 9 ship, association, corporation, governmental subdivision, public
- 10 or private school, or public or private organization.
- 11 (b) "Plumbing" means the practice, materials, and fixtures,
- 12 in or adjacent to a building, structure, or premises, used in the
- 13 installation, maintenance, extension, or alteration of all
- 14 piping, fixtures, plumbing appliances, plumbing appurtenances, as
- 15 defined by the code, in connection with the sanitary drainage or
- 16 storm drainage facilities, plumbing venting systems, medical gas
- 17 systems, backflow preventers, and public or private water supply
- 18 systems.
- 19 (c) "Plumbing contractor" means a licensed master plumber or
- 20 a person who employs a licensed master plumber full-time to
- 21 directly supervise the installation of plumbing as his or her
- 22 representative engaged in the business of plumbing for a fixed
- 23 sum, price, fee percentage, valuable consideration, or other com-
- 24 pensation and who is licensed as a plumbing contractor.
- 25 (d) "Probation" means a sanction which permits a board to
- 26 evaluate over a period of time a licensee's or registrant's
- 27 fitness to practice an occupation regulated by this act.

- 1 Sec. 11. As used in this act:
- 2 (a) "Restitution" means the requirement that a person found
- 3 to be in violation of this act, a rule promulgated under this
- 4 act, or an order issued under this act has caused monetary damage
- 5 to another and that the violator will be required to compensate
- 6 the injured party by an amount equal to the amount of the mone-
- 7 tary damage caused.
- 8 (b) "Stille-DeRossett-Hale single state construction code
- 9 act" means the Stille-DeRossett-Hale single state construction
- 10 code act, 1972 PA 230, MCL 125.1501 to 125.1531.
- 11 (c) "Water service pipe" means the pipe from the water main
- 12 or other source of potable water supply to the water distributing
- 13 system of the building served.
- 14 Sec. 13. (1) There is created a state plumbing board within
- 15 the department. The governor, with the advice and consent of the
- 16 senate, shall appoint 5 United States citizens who are residents
- 17 of the state, 2 of whom shall be licensed plumbing contractors
- 18 who hold a master's license. One shall be a licensed master
- 19 plumber securing permits, and 1 shall be a licensed journey
- 20 plumber, each having 10 years' experience, and a person represen-
- 21 tative of the general public, who with the director of the
- 22 department of environmental quality or his or her authorized rep-
- 23 resentative, a member or employee of the drinking water and radi-
- 24 ologic protection division of the department of environmental
- 25 quality, selected by the director of the department of environ-
- 26 mental quality as voting ex officio members, shall constitute the
- 27 plumbing board. Upon the expiration of the term of office of

- 1 each person so appointed, the governor shall, on or before July 1
- 2 in each year, appoint a successor to hold office for a term of
- 3 years.
- 4 (2) Per diem compensation of the members of the board, other
- 5 than the director and the director of the department of environ-
- 6 mental quality or their authorized representatives and the member
- 7 or employee of the drinking water and radiologic protection divi-
- 8 sion of the department of environmental quality, and the schedule
- 9 for reimbursement of expenses shall be established annually by
- 10 the legislature.
- 11 (3) The board shall meet as often as necessary to fulfill
- 12 its duties under this act, but shall meet not less than 4 times a
- 13 year. A majority of the members appointed and serving shall con-
- 14 stitute a quorum. An approval, decision, or ruling of the board
- 15 does not become effective unless supported by a majority of the
- 16 members present constituting a quorum. A member of the board
- 17 shall not vote by proxy.
- 18 (4) At the first meeting of each calendar year, the board
- 19 shall elect 1 member as chairperson, another as vice-chairperson,
- 20 another as secretary, and other officers as it determines appro-
- 21 priate, for the terms and with the duties and powers as the board
- 22 determines. The chairperson, vice-chairperson, and secretary
- 23 shall be elected from those members appointed to the board by the
- 24 governor.
- 25 (5) The business which the board may perform shall be con-
- 26 ducted at a public meeting of the board held in compliance with
- 27 the open meetings act, 1976 PA 267, MCL 15.261 to 15.275. Public

- 1 notice of the time, date, and place of the meeting shall be given
- 2 in the manner required by the open meetings act, 1976 PA 267,
- 3 MCL 15.261 to 15.275. A member of the board who intentionally
- 4 violates this subsection is subject to the penalties prescribed
- 5 in the open meetings act, 1976 PA 267, MCL 15.261 to 15.275.
- **6** (6) A writing prepared, owned, used, in the possession of,
- 7 or retained by the board in the performance of an official func-
- 8 tion shall be made available to the public in compliance with the
- 9 freedom of information act, 1976 PA 442, MCL 15.231 to 15.246.
- 10 The department shall maintain physical possession of the files of
- 11 the board and shall ensure that applicable laws concerning public
- 12 access to the files are met.
- 13 (7) The board shall recommend to the state construction code
- 14 commission the promulgation of rules necessary for the safe
- 15 design, construction, installation, alteration, and inspection of
- 16 plumbing. The board may also recommend to the state construction
- 17 code commission, after testing and evaluation, that it issue cer-
- 18 tificates of acceptability under the code for a material, pro-
- 19 duct, method of manufacturing, or method of construction or
- 20 installation of plumbing equipment.
- 21 (8) The department, in consultation with the board, shall
- 22 promulgate rules pursuant to the administrative procedures act of
- 23 1969, 1969 PA 306, MCL 24.201 to 24.328, for the administration
- 24 of this act and to effectuate the purposes of this act including,
- 25 but not limited to, the establishing of standards for license
- 26 classifications under this act; the examination and licensing of
- 27 plumbing contractors, master plumbers, and journey plumbers; and

- 1 for the registration of plumbers' apprentices. Before an
- 2 examination or other test required under this act is adminis-
- 3 tered, the board, in consultation with the department, shall
- 4 review and approve the form and content of the examination or
- 5 test. Each examination for a license as a plumbing contractor,
- 6 master plumber, or journey plumber shall be conducted by the
- 7 board and the department, acting jointly.
- 8 Sec. 15. (1) A person shall not engage in or work at the
- 9 business of a plumbing contractor, master plumber, journey plumb-
- 10 er, or apprentice plumber unless licensed or registered by the
- 11 department. Except as provided in subsections (2), (3), and (4),
- 12 plumbing shall be performed by a licensed master or journey
- 13 plumber. A licensed master plumber shall be in charge and
- 14 responsible for proper installation and conformance with the
- 15 code. Plumbing shall not be performed unless the plumbing con-
- 16 tractor who is responsible has secured a permit from the state or
- 17 a governmental subdivision authorized to issue permits.
- 18 (2) A license is not required for the following work:
- 19 (a) Minor repair work.
- 20 (b) The installation of a building sewer or water service
- 21 pipe provided that a permit is secured from the responsible
- 22 enforcing agency and inspections are performed. The installa-
- 23 tions shall comply with the applicable code.
- (c) The installation of domestic water treatment and filter-
- 25 ing equipment that requires modification to an existing cold
- 26 water distribution supply and associated waste piping in
- 27 buildings if a permit is secured, required inspections performed,

  - 1 and the installation complies with the applicable code. If the
  - 2 enforcing agency determines a violation exists, it shall be cor-
  - 3 rected by the responsible installer.
  - 4 (3) A homeowner may install his or her own plumbing, build-
  - 5 ing sewer, or private sewer in his or her single-family dwelling
  - 6 if a permit is secured.
  - 7 (4) The installation of medical gas piping providing the
  - 8 installation shall be performed under the supervision of a
  - 9 licensed plumbing contractor.
    - [(5) This act does not prevent a person from performing any activities within the scope of licensure under any other licensure act or applicable codes for that licensed professional adopted pursuant to law.]
- 10 Sec. 17. (1) The board shall grant licenses or registra-
- 11 tions to qualified applicants for examination or registration.
- 12 The character, experience, and fitness of an applicant for exami-
- 13 nation or registration shall also be taken into consideration.
- 14 Each applicant shall be of good moral character as defined and
- 15 determined under 1974 PA 381, MCL 338.41 to 338.47.
- 16 (2) The plumbing contractor's examination shall consist of,
- 17 but not be limited to, questions designed to test an individual's
- 18 knowledge of this act, any rules promulgated under this act, the
- 19 Stille-DeRossett-Hale single state construction code act, and the
- 20 administration and enforcement procedures of the code. The
- 21 department shall arrange for plumbing contractor examinations to
- 22 be held in the months of March, June, September, and December of
- 23 each year in the Lower Peninsula and shall arrange for at least 1
- 24 plumbing contractor examination to be held in the Upper Peninsula
- 25 each year.
- 26 (3) The master plumber's examination shall consist of, but
- 27 not be limited to, oral and written tests and shall cover the

- 1 science and practice of plumbing, knowledge of the state plumbing
- 2 code, laws, rules, regulations, interpretation of charts and
- 3 blueprints, and plans of plumbing installations. The department
- 4 shall arrange for master plumber examinations in the months of
- 5 March, June, September, and December of each year in the Lower
- 6 Peninsula and shall arrange for at least 1 master plumber's exam-
- 7 ination to be held in the Upper Peninsula each year.
- **8** (4) The journey plumber's examination shall consist of, but
- 9 not be limited to, oral, written, and practical tests and shall
- 10 cover the theory and practice of plumbing and knowledge of the
- 11 state plumbing code, rules, and regulations. The department
- 12 shall arrange for journey plumber examinations to be held in the
- 13 months of March, June, September, and December of each year in
- 14 the Lower Peninsula and shall arrange for at least 1 journey
- 15 plumber's examination to be held in the Upper Peninsula each
- **16** year.
- 17 (5) An application to take an examination shall be submitted
- 18 to the department no later than 20 days before the date of the
- 19 examination.
- 20 Sec. 19. Applicants for plumbing contractor, master, or
- 21 journey licensure under this act may sit for examination upon
- 22 doing both of the following:
- 23 (a) Filing an application with the department, on a form
- 24 provided by the department, with the appropriate nonrefundable
- 25 examination fee prescribed in section 31.
- 26 (b) Establishing, in a manner satisfactory to the board, the
- 27 experience requirement or an equivalent of that experience

- 1 requirement for the particular class of licensure by use of a
- 2 notarized statement from current and past employers and master
- 3 plumbers.
- 4 Sec. 21. (1) To qualify for a plumbing contractor license,
- 5 the applicant must either hold a master plumber license or employ
- 6 the holder of a master plumber license as his or her
- 7 representative. Only an owner of a sole proprietorship or part-
- 8 nership, or an officer of a corporation or limited liability com-
- 9 pany, may apply for licensure as a plumbing contractor.
- 10 (2) The department shall issue a plumbing contractor's
- 11 license to a person who does all of the following:
- 12 (a) Files a completed application on a form provided by the
- 13 department that includes the following information:
- 14 (i) A statement listing the complete address of each place
- 15 where the applicant has resided and has been engaged in business
- 16 during the last 5 years including the length of residences and
- 17 types of businesses engaged in or employments.
- 18 (ii) The name of the applicant, the name of the business,
- 19 and the location of the place for which the license is desired.
- 20 (iii) The name of the business owner or president of the
- 21 corporation and the name of the applicant, if different from the
- 22 name of the business owner or president, and his or her title.
- 23 (iv) The name, residence address, and license number of the
- 24 licensed master plumber who represents the person.
- 25 (b) Pays the examination fee prescribed in section 31 and
- 26 passes an examination provided for by the board and the
- 27 department.

- 1 (c) Pays the license fee prescribed in section 31.
- 2 (3) A licensed plumbing contractor may operate 1 or more
- 3 branch offices in this state bearing the same firm name provided

- 4 a licensed master plumber is in charge and has the responsibility
- 5 of supervision at each branch.
- **6** (4) When a license is issued to a plumbing contractor repre-
- 7 sented by a master plumber, the plumbing contractor and the
- 8 master plumber are jointly and severally responsible for exercis-
- 9 ing the supervision or control of the plumbing operations neces-
- 10 sary to secure full compliance with this act, the rules promul-
- 11 gated under this act, and all other laws and rules related to the
- 12 installation of plumbing.
- 13 (5) Both a person other than a plumbing contractor and the
- 14 master plumber are jointly and severally responsible for exercis-
- 15 ing the supervision or control of the plumbing operations neces-
- 16 sary to secure full compliance with this act, the rules promul-
- 17 gated under this act, and all other laws and rules related to the
- 18 installation of plumbing.
- 19 (6) If a plumbing contractor is represented by a licensed
- 20 master plumber who ceases to represent the plumbing contractor,
- 21 the plumbing contractor has 30 days thereafter in which to desig-
- 22 nate another licensed master plumber as the representative of the
- 23 plumbing contractor. The plumbing contractor shall notify the
- 24 department in writing of the change.
- 25 (7) A person applying for a plumbing contractor license
- 26 shall also pay any amount required to be paid under the
- 27 construction lien act, 1980 PA 497, MCL 570.1101 to 570.1305,

- 1 which amount shall be paid to the department for deposit in the
- 2 homeowner construction lien recovery fund. An assessment imposed
- 3 upon a master plumber is considered sufficient to fulfill any
- 4 assessment obligation that may exist for a plumbing contractor.
- 5 (8) A person who, on the effective date of this act, is
- 6 licensed as a master plumber under former 1929 PA 266 or employ-
- 7 ing a licensed master plumber shall, upon payment of the plumbing
- 8 contractor license fee and upon furnishing the department with
- 9 satisfactory evidence of having been engaged in a business as a
- 10 master plumber for a minimum of 3 out of the 5 years immediately
- 11 preceding the effective date of this act, be granted a plumbing
- 12 contractor license without examination if the person applies
- 13 within 6 months after the effective date of this act.
- 14 (9) A licensed plumbing contractor shall display in a con-
- 15 spicuous place at the entrance of the place of business a sign
- 16 bearing the company name and the name of the licensed master
- 17 plumber and license number in letters not less than 3 inches
- 18 high.
- 19 Sec. 23. (1) The department shall issue a master plumber's
- 20 license to a person not less than 18 years of age who does all of
- 21 the following:
- 22 (a) Files a completed application on a form provided by the
- 23 department.
- 24 (b) Pays the examination fee prescribed in section 31 and
- 25 passes an examination provided for by the board and the
- 26 department.

- 1 (c) Pays the license fee prescribed in section 31.
- 2 (d) Holds a journey plumber license issued under this act or

- 3 former 1929 PA 266 and has gained 4,000 hours' experience in work

- 6 (2) As a condition of renewal of a master plumber's license,
- 7 the master plumber shall demonstrate the successful completion of

- 21 license to a person not less than 18 years of age who does all of
- 22 the following:
- 23 (a) Files a completed application on a form provided by the
- 24 department.
- 25 (b) Pays the examination fee prescribed in section 31 and
- 26 passes an examination provided for by the board and the
- 27 department.

- 2 (d) Has at least 6,000 hours' experience gained over a

- **6** (2) As a condition of renewal of a journey plumber's
- 7 license, the journey plumber shall demonstrate the successful
- 8 completion of a course, approved by the board, concerning any
- 9 update or change in the code within 12 months after the update or
- 10 change in that code. This requirement applies only during or
- 11 after those years that the code is updated or changed.
- 12 Sec. 27. (1) An individual employed as an apprentice
- 13 plumber shall register with the department on a form provided by
- 14 the department within 30 days after employment.
- 15 (2) An apprentice registration is invalid after 5 years from
- 16 the date of initial registration unless the registered apprentice
- 17 applies for and takes the examination for journey license. The
- 18 registration remains valid until either a license is issued or
- 19 the apprentice fails to take the exam.
- 20 (3) Upon request by the apprentice to the board, the board
- 21 may grant an extension of an apprentice registration for a period
- 22 of time as determined appropriate by the board.
- 23 (4) An apprentice plumber shall, as his or her principal
- 24 occupation, be engaged in learning and assisting in the installa-
- 25 tion of plumbing under the direct on-site jobsite supervision of
- 26 a journey or master plumber.

- 1 Sec. 29. (1) A person licensed as a master plumber may
- 2 request that the master plumber license be retained by the
- 3 department as an inactive license for a period not to exceed
- **4** 3 years.
- 5 (2) An inactive master plumber license shall be issued as
- 6 active upon the request of the licensee and the payment of the
- 7 reinstatement fee as described in section 31 as long as the indi-
- 8 vidual holds a journey plumber license and the individual's jour-
- 9 ney plumber license has been renewed each year.
- 10 (3) A person shall not simultaneously hold an active master
- 11 and journey plumber license. An individual holding an active
- 12 master plumber license may work as a journey plumber.
- Sec. 31. (1) A license or apprentice registration issued
- 14 under this act must be renewed not more than 60 days after the
- 15 renewal date. It is the responsibility of a licensee or regis-
- 16 trant to renew a license or registration. The department shall
- 17 send a renewal application to the last known address of a
- 18 licensee or registrant on file with the department. Every holder
- 19 of a license or registration issued under this act shall promptly
- 20 notify the department of a change in his or her business or resi-
- 21 dence address. The failure of a licensee or registrant to notify
- 22 the department of a change of address does not extend the expira-
- 23 tion date of a license or registration. The department may issue
- 24 licenses for up to 3 years in duration.
- 25 (2) The annual fees for initial licensure, apprentice
- 26 plumber registration, or renewal of a license and registration
- 27 issued under this act are as follows:

- 1 (5) Master plumbers, journey plumbers, and apprentice
- 2 plumbers are required to carry their licenses and a

- **6** (6) If the plumbing, reconstruction, alteration, or repair

- 6 (c) An act of gross negligence.
- 7 (d) False advertising.
- 8 (e) An act that demonstrates incompetence.
- **9** (f) A violation of this act or rule promulgated under this
- **10** act.
- 11 (3) Notwithstanding section 47, the board upon recommenda-
- 12 tion of the department shall suspend or revoke the license of a
- 13 person whose failure to pay a lien claimant results in a payment
- 14 being made from the homeowner construction lien recovery fund
- 15 pursuant to the construction lien act, 1980 PA 497, MCL 570.1101
- 16 to 570.1305. The license shall not be renewed and a new license
- 17 shall not be issued until that person has made full restitution
- 18 to the fund, including the costs of litigation and interest at
- 19 the rate set by section 6013 of the revised judicature act of
- 20 1961, 1961 PA 236, MCL 600.6013.
- 21 (4) Activity regulated under this act shall not be performed
- 22 by a person whose license or registration has been suspended or
- 23 revoked or whose license or registration has expired.
- Sec. 45. The board shall review the license of a person
- 25 upon notice by the department that the person has violated the
- 26 asbestos abatement contractors licensing act, 1986 PA 135,
