THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 17F. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION
- 2 (4), IF A RECIPIENT OF SUPPORT OR PAYER FILES WITH THE COURT A
- 3 POSTJUDGMENT MOTION TO TRANSFER THE DOMESTIC RELATIONS MATTER TO
- 4 A DIFFERENT COUNTY OFFICE, THE COURT SHALL TRANSFER THE CASE IF
- 5 THE COURT FINDS ALL OF THE FOLLOWING:
- 6 (A) THE TRANSFER WOULD SERVE THE CONVENIENCE OF THE PARTIES
- 7 AND BE CONSISTENT WITH THE CHILD'S BEST INTERESTS.
- 8 (B) NEITHER PARTY RESIDED IN THE COUNTY OF CURRENT JURISDIC-
- 9 TION FOR AT LEAST 6 MONTHS BEFORE THE MOTION IS FILED.

- (C) AT LEAST 1 PARTY HAS RESIDED IN THE COUNTY TO WHICH THE 1

- (D) THE COUNTY TO WHICH THE TRANSFER IS REQUESTED IS NOT
- 5 CONTIGUOUS TO THE COUNTY OF CURRENT JURISDICTION.
- (2) THE COURT MAY CHARGE A FEE OF \$20.00 TO FILE A MOTION
- 7 UNDER THIS SECTION. THE COURT SHALL WAIVE THE FILING FEE FOR AN
- 8 INDIGENT INDIVIDUAL AS PROVIDED IN THE MICHIGAN COURT RULES.
- (3) IF THE COURT TRANSFERS A DOMESTIC RELATIONS MATTER, THE
- 10 TRANSFERRING OFFICE SHALL SEND TO THE RECEIVING OFFICE ALL
- 11 RECORDS RELATED TO THE DOMESTIC RELATIONS MATTER ACCORDING TO THE
- 12 PROCEDURE ESTABLISHED BY THE MICHIGAN SUPREME COURT.
- (4) THE COURT IS NOT REQUIRED TO TRANSFER THE DOMESTIC RELA-
- 14 TIONS MATTER MORE THAN 1 TIME IN A 12-MONTH PERIOD. THE COURT
- 15 MAY TRANSFER THE DOMESTIC RELATIONS MATTER MORE THAN 1 TIME IN A
- 16 12-MONTH PERIOD UNDER THE CONDITIONS SET FORTH IN SUBSECTION (1).
