January 31, 2001, Introduced by Reps. Howell, Tabor, Woronchak, Kuipers, Richardville, Newell, Gilbert, Ruth Johnson, Van Woerkom, Bishop, Shackleton, DeRossett, Garcia, Middaugh, Stewart and Vear and referred to the Committee on Conservation and Outdoor Recreation.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16r of chapter XVII (MCL 777.16r), as amended
by 2000 PA 279.
