THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- (1) FOR TAX YEARS THAT END AFTER DECEMBER 31, 1 SEC. 269.
- 2 2000, AN ELIGIBLE TAXPAYER MAY CLAIM A CREDIT UNDER THIS SECTION
- 3 EQUAL TO THE SUM OF THE FOLLOWING COSTS PAID, AND NOT OTHERWISE
- 4 REIMBURSED TO THE TAXPAYER, BY THE ELIGIBLE TAXPAYER IN THE TAX
- 5 YEAR:
- (A) TEN PERCENT OF THE COST FOR THE PURCHASE AND INSTALLA-
- 7 TION OF AN APPLIANCE THAT HAS THE ENERGY STAR LABEL UNDER THE
- 8 VOLUNTARY ENERGY STAR LABEL PROGRAM OPERATED JOINTLY BY THE FED-
- 9 ERAL ENVIRONMENTAL PROTECTION AGENCY AND THE FEDERAL DEPARTMENT

- 1 (B) ONE HUNDRED PERCENT OF THE COST OF WEATHERIZATION OF THE

- 14 OR WATER HEATERS, AND INSTALLATION OF FURNACE IGNITION SYSTEMS,
