by amending section  $3406m \, (MCL \, 500.3406m)$ , as added by 1998 PA 402.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3406m. (1) An insurer that delivers, issues for deliv-
- 2 ery, or renews in this state an expense-incurred hospital, medi-
- 3 cal, or surgical policy or certificate that requires an insured
- 4 to designate a participating primary care provider and provides
- 5 for annual well-woman examinations and routine obstetrical and
- 6 gynecologic services AND A HEALTH MAINTENANCE ORGANIZATION shall
- 7 permit a female insured OR ENROLLEE to access an
- 8 obstetrician-gynecologist for annual well-woman examinations and
- 9 routine obstetrical and gynecologic services.

- 1 (2) An insurer AND A HEALTH MAINTENANCE ORGANIZATION shall
- 2 not require prior authorization or referral for access under
- 3 subsection (1) to an obstetrician-gynecologist who is participat-
- 4 ing OR AFFILIATED with the insurer OR HEALTH MAINTENANCE
- 5 ORGANIZATION. An insurer OR HEALTH MAINTENANCE ORGANIZATION may
