## **HOUSE BILL No. 5096**

September 25, 2001, Introduced by Rep. Stamas and referred to the Committee on Insurance and Financial Services.

A bill to amend 1956 PA 218, entitled

"The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding sections 2128 and 7307.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- (1) IF A PERSON WHO IS AN INSURED PARTY UNDER A 1 SEC. 2128.
- 2 HOME INSURANCE POLICY TRANSFERS OWNERSHIP OF THE PROPERTY TO A
- 3 QUALIFYING TRUST, THE QUALIFYING TRUST SHALL BE CONSIDERED AN
- 4 INSURED PARTY UNDER THE HOME INSURANCE POLICY AND COVERAGE SHALL
- 5 EXTEND TO THE QUALIFYING TRUST.
- (2) AS USED IN THIS SECTION, "QUALIFYING TRUST" MEANS A
- 7 TRUST THAT MEETS BOTH OF THE FOLLOWING:
- (A) THE SETTLOR OF THE TRUST IS THE INSURED PARTY, THE
- 9 INSURED PARTY'S SPOUSE, OR BOTH, UNDER A HO
