A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding sections 217p and 217q.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 217P. (1) THE SECRETARY OF STATE SHALL DEVELOP AND
- 2 ISSUE A "BREAST CANCER AWARENESS" FUND-RAISING PLATE. THE SECRE-
- 3 TARY OF STATE SHALL DESIGN THE PLATE, HAVING THE PINK RIBBON
- 4 EMBLEM OF THE SUSAN G. KOMEN BREAST CANCER FOUNDATION INSCRIBED
- 5 ON THE PLATE. THE WORD "MICHIGAN" SHALL APPEAR ON THE PLATE.
- 6 (2) THE OWNER OF A VEHICLE REQUIRED TO BE REGISTERED UNDER
- 7 THIS ACT MAY APPLY, ON A FORM PRESCRIBED BY THE SECRETARY OF
- 8 STATE, FOR A CANCER AWARENESS REGISTRATION PLATE INSTEAD OF A
- 9 STANDARD REGISTRATION PLATE.
- 10 (3) UPON APPLICATION AND PAYMENT OF THE REGULAR REGISTRATION
- 11 TAX AND A \$5.00 SERVICE FEE AND A DONATION OF \$25.00, THE

- 1 SECRETARY OF STATE SHALL ISSUE A CANCER AWARENESS REGISTRATION
- 2 PLATE FOR THE VEHICLE.
- 3 (4) THE SECRETARY OF STATE SHALL DEPOSIT THE \$25.00 DONATION
- 4 INTO THE BREAST CANCER AWARENESS FUND ESTABLISHED UNDER
- **5** SECTION 217Q.
- 6 SEC. 2170. (1) THE BREAST CANCER AWARENESS FUND IS CREATED
- 7 WITHIN THE STATE TREASURY.
- 8 (2) THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS
- 9 FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER

- 11 SHALL CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND

- 13 (3) MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL
- 14 REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- 15 (4) THE STATE TREASURER SHALL DISBURSE THE MONEY IN THE FUND
- 16 QUARTERLY TO THE MICHIGAN CHAPTER OF THE AMERICAN CANCER
- 17 SOCIETY.
- 18 (5) AS USED IN THIS SECTION, "FUND" MEANS THE BREAST CANCER
- 19 AWARENESS FUND CREATED IN SUBSECTION (1).
- 20 (6) THE ENTITY RECEIVING MONEY UNDER THIS SECTION SHALL PRO-
- 21 VIDE AN ANNUAL ACCOUNTING OF THE USE OF THE MONEY TO THE STATE
- 22 TREASURER.
